Nkomazi Municipality cordially invites interested parties to tender/bid for a panel of service providers to tender for appointment of a panel of maximum 10 (ten) contractors for the refurbishment and replacement of civil works, mechanical and electrical equipment's at water, waste water treatment works as and when required for 36 months for Nkomazi local municipality. A preferential system shall apply whereby this contract will be allocated to bidder in accordance with the preferential procurement policy framework Act no. 5 of 2000 and as defined in the bid document, read in conjunction with the preferential procurement regulation 2022 where 80 points will be allocated in respect of price and 20 points in respect of targeted goals.

Completed Bid documents must be deposited on/before **12H00 on 13/03/2025** on the tender box situated at the main entrance of the municipality (Civic Centre), 9 Park Street Malelane 1320

Tender/bid documentation must be submitted in a sealed envelope or container on which the tender/bid number and addresses are clearly marked. No tenders /bids transmitted by fax or E-mail will be accepted. It must be noted that the municipality is not bound to accept the lowest on any other tender. Tenders/Bids which is incomplete or filled incorrectly, not filled in the official bid documentation or which is received after the close of the bids will be ignored.
