- Evidence of physical registered office
- Copies of company's most recent audited annual financial report for at least three years
- Proven experience in delivering similar services, supplies or works in South Sudan.
- Evidence of financial stability and ability to deliver large-scale projects.
- Past performance and experience; provide recommendation letter prove of substantial contracts/Local Purchase Order (LPO) for similar works completed from current or previous client particularly NGO, INGO or UN Agencies
- Availability of required human resources, equipment, and infrastructure.
