- reject any Proposal which does not conform to instructions and specifications which are detailed herein.
- disqualify Proposals submitted after the stated submission deadline 06 May 2025;
- award a contract in connection with this Proposal at any time after the RFP's closing date.
- award a contract for only a portion of the proposed Goods/Services which are reflected in the scope of this RFP.
- split the award of the contract between more than one Supplier/Service provider, should it at Foskor's discretion be more
  advantageous in terms of, amongst others, cost or developmental considerations.
- cancel the bid process.

#### 10. SECURITY CLEARANCE

Acceptance of this bid could be subject to the condition that the Successful Respondent, its personnel providing the Goods/Services, and its subcontractor(s) must obtain security clearance from the appropriate authorities to the level of **CONFIDENTIAL/ SECRET/TOP SECRET**. Obtaining the required clearance is the responsibility of the Successful Respondent. #### 11. NATIONAL TREASURY'S CENTRAL SUPPLIER DATABASE



## SECTION 3: BACKGROUND, OVERVIEW AND SCOPE OF REQUIREMENTS

#### 1. BACKGROUND

Foskor (Pty) Ltd. is an opencast mining and beneficiation operation situated in Phalaborwa. The core business of the Phalaborwa operation is the mining and beneficiation of phosphate rock. (The Foskor operation situated in Richards Bay is primarily a producer of phosphoric acid, phosphate-based fertilizers, and lower volumes of sulphuric acid).

Foskor (Pty) Ltd (Mining Division) is an Open Cast Mine that produces phosphate rock for export or domestic beneficiation. Approximately 2.2 million tons of phosphate rock is produced annually. The product is finely ground apatite mineral from coarsely crystalline calcium-fluoride-phosphate compound of igneous origin. The intermediate and final products are for the domestic and intonational markets and provide the following advantages:

- · Make South Africa self-sufficient from phosphate imports.
- · Earn foreign currency from the export of the products.
- Create approximately 2000 direct job opportunities, with associated indirect job opportunities in the Greater Phalaborwa
  region. The dominating rock type in the Phalaborwa area, older than 3000 million years, is granite-gneiss of the Archaic
  Complex. Intrusive in this are younger rock types of the Phalaborwa Igneous Complex. Inclusions of serpentine, talc and
  amphibole schist are found in the granite-gneiss and igneous rock.

#### 2. EXECUTIVE OVERVIEW

Whereas Foskor is seeking a partner(s) to provide solutions in Phalaborwa, it also seeks to improve its current processes for providing these Services to its end user community throughout its locations.

#### 3. SCOPE OF REQUIREMENTS

Quarterly sampling and analysing of stack emissions for PM, S02 and NOX (reported at 10% 02) for 10 stacks.

Quarterly sampling of TVOCs by installing twelve passive samplers/ Fence line monitoring of TVOCs on the randomly selected sites around the mine.

Bi-annual sampling and analysing of Total Volatile Organic Compounds (TVOC) for 20 Fuel tanks (Leak detection test).

Annual Pollution abatement equipment optimization (Scrubber efficiency) for eight dryers using Isokinetic sampling method.

The reference method to be used should meet the requirements of the National Environmental Management Act 107 of 1998, National Environmental Management: Air Quality Act 39 of 2004 and other associated air quality legal and other acceptable requirements furthermore the laboratory to be used for analysis must be ISOI 705 accredited. Detailed Scope on Table below.



#### THE NATIONAL INDUSTRIAL PARTICIPATION PROGRAMME

#### INTRODUCTION

The National Industrial Participation Programme (NIPP), which is applicable to all government procurement contracts that have imported content, became effective on 1 September 1996. The NIP policy and guidelines were fully endorsed by the Cabinet on 30 April 1997. Furthermore, the Operator will not otherwise modify, amend or alter any personal information and the information of a third party submitted by Foskor or disclose or permit the disclosure of any personal information and the information of a third party to any third party without prior written consent from Foskor.
- 8. The Operator shall, at all times, ensure compliance with any applicable laws put in place and maintain sufficient measures, policies and systems to manage and secure against all forms of risks to any information that may be shared or accessed pursuant to the services offered to Foskor in terms of this Agreement (physically, through a computer or any other form of electronic communication).
- 9. The Operator shall notify Foskor in writing of any unauthorised access to personal information and the information of a third party, cybercrimes or suspected cybercrimes, in its knowledge and report such crimes or suspected crimes to the relevant authorities in accordance with applicable laws, after becoming aware of such crimes or suspected crime. The Operator must inform Foskor

of the breach as soon as it has occurred to allow Foskor to take all necessary remedial steps to mitigate the extent of the loss or compromise of personal information and the information of a third party and to restore the integrity of the affected personal information as quickly as is possible.

Foskor may, in writing, request the Operator to confirm and/or make available any personal information and the information of a third party in its possession in relation to Foskor and if such personal information has been accessed by third parties and the identity thereof in terms of the POPIA.
