uMngeni-Uthukela Water operations concern the supply of bulk water and the disposal of bulk waste water. The plant has two raw water sources which are Mhlathuze River and Nsezi Lake. The raw water turbidity ranges from 10NTU up to more than 4000 NTU. The plant is consist of the following process units: coagulation, flocculation, sedimentation, re-coagulation, re-flocculation, dissolved air flotation, filtration and disinfection.
