STANDARD CONDITIONS OF TENDER (Goods / Services)

1. DEFINITIONS

General:

- (1) Defined words / phrases are printed in *Italic font*.
- (2) Definitions apply to the singular as well as the plural.
- (3) Any reference to the masculine gender shall be taken to include the feminine and any reference to the feminine gender shall be taken to include the masculine.
- (4) The words “bid” and “tender”, and “bidder” and “tenderer” can be used interchangeably.
- (5) All definitions as defined in the **General Conditions of Contract** are applicable to these **Standard Conditions of Tender**. These definitions include:
 - “Closing time”
 - “Contract”
 - “Contract Price”
 - “Corrupt practice”
 - “Countervailing duties”
 - “Country of origin”
 - “Day”
 - “Delivery”

- (6) **Bid or Tender:** The offer submitted in respect of an invitation to submit such an offer.
- (7) **Bidder or Tenderer:** An entity (company, close corporation, partnership, joint venture, sole proprietor) which submits a *bid/tender*.
- (8) **Municipality:** The eThekweni Municipality, as represented by the duly authorised delegate, official or committee.
- (9) **SCT:** Special Conditions of Tender (found in Section 3).
- (10) **Week:** A period of seven (7) consecutive *days*.
- (11) **Material Deviation:** A material deviation or qualification is one which, in the *Municipality’s* opinion, would:
 - (a) Detrimentally affect the scope, quality, or performance of the services or supply identified in the Scope;
 - (b) Significantly change the *Municipality’s* or the *Tenderer’s* risks and responsibilities under the contract; or
 - (c) Affect the competitive position of other *Tenderers* presenting responsive *tenders*, if it were to be rectified.

2. CONDITIONS OF TENDER & CONTRACT

The specification will be governed by the **Standard Conditions of Tender** (Goods and Services), **Special Conditions of Tender (SCT)**, **General Conditions of Contract (GCC)** (Government Procurement General Conditions (July 2010), as amended by National Treasury Circular 52 dated 30 July 2010), the **Special Conditions of Contract (SCC)**, the **Occupational Health and Safety Act** (Act No. 85 of 1993), and the **eThekweni Code of Conduct**.

Complete Acceptance of Conditions

Unless otherwise expressly stipulated in a letter covering the *tender*, every *Tenderer* shall be deemed to have waived, renounced, and abandoned any conditions printed or written upon any stationery used for the purpose of, or in connection with, the submission of their *tender*, which are in conflict with the **General Conditions of Contract** and **Special Conditions of Contract**. *Tenderers* are advised that any *material divergences / qualifications* from the official Conditions or Specification will render their *tenders* liable to disqualification.

3. TENDER INFORMATION

(1) General

- (a) *Tenders* will be liable for rejection unless made out on the official tendering documentation.
- (b) Any alterations effected upon any of the tendering documents must be clearly shown by means of a hand written (black, non-erasable ink), or typed, entry and must be signed in full by the *Tenderer*. **The use of correction fluid is not permitted.**
- (c) *Tenderers* may submit alternative solutions that, in the *Tenderer’s* opinion, are to the *Municipality’s* advantage economically and technically. Full technical details of the alternative *tender(s)* shall be submitted with the tender documents. Alternative *tender(s)* shall be submitted separately.

(2) Obtaining Tender Documentation

All tenders must be submitted on official tender documentation issued, in electronic format, by the eThekweni Municipality. Electronically downloaded documentation (obtainable free of charge) should be printed and suitably bound by tenderer.

(3) Queries Relating to this Tender

Queries can be directed to the person / Department as stated in the **SCT**.

(4) Briefing Session (Clarification Meeting)

Details of the briefing session are stated in the **SCT**.

Failure to attend a **compulsory** briefing session will invalidate the *tender*. *Tenderers* must sign the attendance list in the name of the tendering entity. *Tenders* will only be evaluated from those tendering entities appearing on the attendance list.

(5) Closing Date and Delivery of Tender Submissions

Sealed *tenders* made out on the enclosed Official Tender Form, which shall be signed by or on behalf of the *Tenderer*, and addressed to the City Manager, marked with the appropriate Tender number, must be placed in the **Tender Box** as stated in the **SCT** not later than the **date and time** as stated in the **SCT**, where after they will be opened publicly.

All tender documents **must** be placed directly into the Tender Box and should not be delivered to any other Municipal Department. *Bidders* are advised that *tenders* submitted by post, fax or email **will not** be considered. All couriered documents must be placed directly into the Tender Box and should not be delivered to any other Municipal Department.

Any *tender* received after the closing date and time stated for the receipt thereof **shall not** be accepted for consideration and shall be returned to the *Tenderer*.

(6) Tender Validity and Withdrawal of Tenders

Tenders must hold good until 16:00 of the 5th week following the date on which *tenders* are opened, or during such other period as may be specified in the **SCT**. The *Municipality* may, during the period for which *tenders* are to remain open for acceptance, authorize a *Tenderer* to withdraw their *tender* in whole or in part on condition that the *Tenderer* pays to the *Municipality* on demand, a sum of one thousand Rand (R1,000.00). The *Municipality* may, if it thinks fit, waive payment of such sum in whole or in part.

4. RETURNABLE SCHEDULES, FORMS, CERTIFICATES

Each *Tenderer* shall complete fully and accurately the following documents and submit these documents with the *tender*:

- (1) **Authority of Signatory:** In terms of Clause 4(5)(c) of the Conditions of Tender.
- (2) **Tax Compliance Status PIN / Tax Clearance Certificate:** SARS has introduced a new Tax Compliance Status System. Tenderers can submit a Tax Compliance Status PIN (TCS PIN) instead of an original Tax Clearance Certificate. This TCS PIN can be used by third parties to certify the taxpayer's real-time compliance status.
- (3) **Declaration of Municipal Fees:** Only those *Bidders* whose municipal fees are fully paid, or those that have concluded acknowledgement of debt agreements with the *Municipality*, are eligible to *tender*.
All *Bidders* must sign the Declaration of Municipal Fees returnable form, declaring that their municipal fees are in order or that acknowledgement of debt agreements have been concluded, and include the relevant account numbers in the declaration. Failure to include account numbers or sign will invalidate the *tender*. The completion of the declaration is also applicable to *Bidders* outside of the eThekweni Municipal Area.
- (4) **Declaration with respect to the Occupational Health and Safety Act:** Acceptance of undertaking in terms of the Occupational Health and Safety Act (Act 85 of 1993) and the relevant Regulations.

(5) Municipal Bidding Documents (which includes):

- (a) **MBD 4: Declaration of Interest:** All *Bidders* are to sign the Declaration of Interest wherein they declare any relationship that may exist with an official of the Municipality involved in the evaluation process.
Regulation 44 of the Supply Chain Management Regulations states that a Municipality or Municipal Entity may not make any award to a person:
 - (i) Who is in the service of the state;
 - (ii) If that person is not a natural person, of which any Director, Manager, Principal, Shareholder or Stakeholder is a person in the service of the state; or
 - (iii) Who is an advisor or consultant contracted with the Municipality or municipal entity.
 Should a contract be awarded, and it is subsequently established that Regulation 44 has been breached, the Municipality shall have the right to terminate the contract with immediate effect.
- (b) **MBD 5: Declaration for Procurement Above R10 Million (if applicable):** For all procurement expected to exceed R10 million (all applicable taxes included), tenderers must complete this questionnaire.
- (c) **MBD 6.1: Preference Points Claim Form:** For the awarding of Preference Points, *Bidders* are required to complete the attached MBD 6.1 form and return it with their tender submission. Failure on the part of a tenderer to complete and submit this form will be interpreted to mean that preference points for **Specific Goals** are not claimed.
The Municipality reserves the right to require of a tenderer, either before a bid is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the Municipality.
- (d) **MBD 8: Declaration of Bidders Past Supply Chain Management Practices Form:** This form serves as a declaration to be used by municipalities and municipal entities in ensuring that when goods and services are being procured, all reasonable steps are taken to combat the abuse of the supply chain management system.
- (e) **MBD 9: Certificate of Independent Bid Determination:** Section 4(1)(b)(iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms if it involves collusive tendering or tender rigging. In order to give effect to this, the Certificate of Bid Determination must be completed and submitted with the tender.

(5) Official Tender Form (see Section 9)**(a) Legal Status of Tenderer**

It is essential for the purpose of entering into a legal contract that *Bidders* state on the Official Tender Form, under "Name and Address of Tenderer ", their full legal status:

- (i) the full registered name of the company making a *tender*; or
- (ii) if the *Tenderer* is a person conducting business under a recognised trading name then:
 - State the name of the person(s);
 - State recognised trading name; and
 - State whether an owner, co-owner, proprietor, etc.

(b) Signing of Official Tender Form

Failure of a *Tenderer* to complete, in its entirety, and sign the Official Tender Form will invalidate the *tender*.

(c) Authority of Signatory

Bidders are to complete and sign the Authority of Signatory returnable document, and attach the required additional documents.

(d) Differences or Discrepancies

Should there be any difference or discrepancy between the prices or price contained in the Official Tender Form and those contained in any covering letter from the *Tenderer*, the prices or price contained in the Official Tender Form shall prevail.

(6) Any additional Schedules, Forms, or Certificates as stated in the SCT.**5. INFORMATION TO BE SUPPLIED REGARDING SUB-CONTRACTORS**

Bidders are to state in their *tenders*, or covering letters, whether, if the contract were to be awarded to them, the whole of the work would be executed by them in their own workshop / factory. If the answer is in the negative, they are required to state which part(s) would be handed to sub-contractors and the name and address of such sub-contractors.

6. SAMPLES

Bidders may be required to state where samples of the full range of products can be inspected or be required to submit samples for inspection prior to the closing date of the *tender*.

7. MANUFACTURERS

The names of the manufacturers of the goods or equipment offered must be stated in the *tender*.

Bidders who are not manufacturers, accredited distributors, or agents must provide a valid agreement / Joint Venture Agreement, entered into with the manufacturer, accredited distributors, or agents, with their submission. This agreement must meet all the requirements as laid down in the *tender* document, and must cover the contract period.

8. CLARIFICATION

The Head: Supply Chain Management Unit, or an authorized representative, may request clarification or further information on any aspect of the *tender*. The *Tenderer must* supply the requested information within the time specified. Failure to comply will render the *tender* non-responsive.

9. PRICING

Bidders would be precluded from this *tender* if their pricing structure deviates from the Official Tender Form.

(1) Nett Prices

All prices shall be quoted in South African currency (Rand) after deduction of any brokerage or discount allowed to the Municipality.

(2) Unit Prices

Bidders shall quote only one price in respect of each item. Such price is to hold good for the full duration of the contract period, being subject to variation only in accordance with specified criteria, as stated in the *Conditions of Contract*.

(3) Firm Tenders

Bidders may submit firm prices for each 12 month period. These prices shall be free from all fluctuations, including any statutory increases.

(4) Value Added Tax (V.A.T)

Prices exclusive and inclusive of VAT must be stated separately on the Official Tender Form.

10. ESTIMATED QUANTITIES

The estimated quantities are set out in Section 8 : Bill of Quantities / Schedule of Rates/Activities which forms part of the official tender documents. The quantities are stated purely for the information of the *Bidders* and are in order to ascertain an estimated total contract price. The *Supplier* will, however, be bound to supply whatever quantity or quantities the *Municipality* may actually require, and may exceed, or be less than, the estimated quantities stated.

11. DELIVERY, RISK, PACKAGES, ETC

- (1) Unless otherwise provided, all goods are to be supplied only against the form of order issued by the *Municipality*.
- (2) *Bidders* shall quote a unit price which shall include delivery to the specified delivery point, as stated in the *SCT*.
- (3) The risk in all goods purchased by the *Municipality* under the contract shall remain with the *Supplier* until such goods shall have been duly delivered.
- (4) *Bidders* shall clearly state the period within which delivery will be made after receipt of the official order, as this may be material in the adjudication of the *tender*.

12. RATES OF EXCHANGE

- (1) Where the goods are imported the *Supplier* shall, within seven days of date of official Purchase Order, arrange through their bankers for the foreign commitment to be covered forward down to the Rand in order to fix the rate of exchange. The *Supplier* shall notify the *Municipality* as soon as possible thereafter regarding the rate which has been fixed on such forward exchange.

Any increase or decrease between the basic rate of exchange as at a date seven days prior to the date of closing of *tenders* and that existing at the date of establishment of the forward exchange cover within the period stipulated above shall be paid or deducted by the Municipality. Upon the failure of the *Supplier* to arrange forward exchange cover, the *Supplier* shall be liable should there be any increase in the basic rate of exchange occurring after the last mentioned date.

The bank charges incurred in obtaining the forward exchange cover shall be for the *Municipality's* account.

- (2) The *Supplier* shall on request:
- Submit documentary proof of the rate of exchange; and
 - When an adjustment is claimed in terms of this sub-clause, whether by the *Supplier* or the *Municipality*, submit documentary proof to the satisfaction of the Deputy City Manager: Treasury in respect of such claim.

13. IMPORT PERMITS

- (1) In order to minimise special importation, *Bidders* should, where possible, have recourse to local suppliers and / or manufacturers.
- (2) *Bidders* must state whether their *tender* is dependent upon the issue of a special import permit or whether they are able to supply the goods by making use of the import facilities available to them.
- (3) In the event of a tender being dependent upon the issue of a special import permit, application for such special import permit shall be made by the Tenderer, unless otherwise provided for in the *SCT*.

14. EVALUATION PROCESS

The procedure for evaluation of responsive Tender Offers will be in accordance with the eThekweni Municipality's current SCM Policy and the Preferential Procurement Policy Framework Act (5 of 2000), and the Preferential Procurement Policy Framework Act Regulations (November 2022).

Details of additional evaluation criteria, if applicable, are stated in the *SCT*.

Evaluation points for price and preference will only be calculated for *Bidders* who comply with the contractual and technical specification, and if applicable, have attained the minimum Functionality Score as stated in the *SCT*.

The evaluation process of responsive *tenders* will be as follows:

- Score each *tender* in respect of the financial offer made and preferences claimed (if any);
- Calculate the total number of evaluation points (T_{EV}) in accordance with the following formula:
 $T_{EV} = N_{FO} + N_P$ where: N_{FO} : is the number of evaluation points awarded for the financial offer; and N_P : is the number of evaluation points awarded for preferences claimed.
- Rank *tenders* from the highest number of evaluation points to the lowest.
- Recommend the *Tenderer* with the highest number of evaluation points for the award of the contract, unless there are compelling and justifiable reasons not to do so.
- Rescore and re-rank all *Bidders* should there be compelling and justifiable reasons not to recommend the *Tenderer* with the highest number of evaluation points, and recommend the *Tenderer* with the highest number of evaluation points, unless there are compelling and justifiable reasons not to do so, and the process set out in this sub-clause is repeated.

(1) Evaluation points awarded for the financial offer:

Reference is to be made to the Special Conditions of Tender (*SCT*), and returnable form 5(c) in Section 4.

INCOME-GENERATING CONTRACTS

The financial offer will be scored using the formula:

$$N_{FO} = W \left(1 + \frac{Pt - P_{max}}{P_{max}} \right)$$

GOODS and SERVICES

The financial offer will be scored using the formula:

$$N_{FO} = W \left(1 - \frac{Pt - P_{min}}{P_{min}} \right)$$

Where the value of W is:

- (a) **90** where the financial value inclusive of VAT of all responsive *tenders* received have a value in excess of R 50,000,000; OR

15. BRIBERY AND COMMUNICATION WITH COUNCILLORS / OFFICIALS

(1) Bribery

No *Tenderer* shall offer, promise or give to any person or person connected with a *tender* or the awarding of a contract, any gratuity, bonus or discount etc, in connection with the obtaining of a contract.

(2) Communication, Councillors and Officials

A *Tenderer* shall not in any way communicate with a member of the *Municipality* or with any official of the *Municipality* on a question affecting any contract for the supply of goods or for any work, undertaking or services which is the subject of a *tender* during the period between the closing date for receipt of *tenders* and the dispatch of the written notification of the *Municipality's* decision on the award of the contract; provided that a *Tenderer* shall not hereby be precluded:

- (a) At the request of the Head: SCM Unit, or an authorized representative, from furnishing him with additional information or with a sample or specimen for testing purposes or otherwise from giving a demonstration so as to enable the recommendation to the Bid Committee on the award of the contract to be formulated;
- (b) From obtaining from the Head : SCM Unit, or an authorised representative, information as to the date upon which the award of the contract is likely to be made, or, after the decision upon the award has been made by the *Municipality* or any Committee to which the *Municipality* has delegated its powers, information as to the nature of the decision or such information as was publicly disclosed at the opening of *tenders* or from submitting to the Accounting Officer in writing any communication relating to their *tender* or the award of the contract or a request for leave to withdraw their *tender*; and
- (c) Provided further that nothing contained herein shall be construed so as to prevent information being sought and obtained from an Official in regard to any decision taken at an open Municipal meeting, or any Committee to which the *Municipality* has delegated its powers.

A contravention of subsection (1) and / or (2), or an attempt to contravene such subsection, shall be reported to the Accounting Officer, who may on receipt of such report disqualify the *tender* of the *Tenderer* concerned.

16. NEGOTIATIONS WITH PREFERRED BIDDERS

The *Municipality* reserves the right to invoke Regulation 24 of Municipal Finance Management Act if required.

- (1) The Accounting Officer may negotiate the final terms of a contract with *Bidders* identified through a competitive tendering process as preferred *Bidders*, provided that such negotiation:
 - Does not allow any preferred *Tenderer* a second or unfair opportunity;
 - Is not to the detriment of any other *Tenderer* ; and
 - Does not lead to a higher price than the *tender* as submitted.
- (2) Minutes of such negotiations must be kept for record purposes.
- (3) Such negotiation may be delegated by the Accounting Officer.

17. CANCELLATION OF TENDER PROCESS

The municipality is entitled to cancel the tender at any time before the award of a tender and the decision to cancel the tender shall be published in the same manner in which the original tender invitation was advertised. The Municipality shall, in no way, be liable for any damages whatsoever, including, without limitation, damages for loss of profit, in any way connected with the cancellation of this bid.

18. ACCEPTANCE OF BID

- (1) The *Municipality* does not bind itself to accept the lowest or any *tender*, and reserves the right to accept the whole or any part of a *tender* to place orders.
- (2) The *Municipality* reserves the right to accept more than one technically and contractually compliant *tender* for part or the whole of the contract and to place orders on the price and availability.
- (3) *Bidders* shall not bind the *Municipality* to any minimum quantity per order.
- (4) The successful *Tenderer* (s) shall be bound to provide any quantities stipulated in the specification.
- (5) Tenders will only be accepted on condition that:
 - (a) The *tender* is signed by a person authorised to sign on behalf of the *Tenderer* .
 - (b) A valid (at time of close of tenders), original, Tax Clearance Certificate OR Tax Compliance Status PIN is included with the *tender* submission. Both should have sufficient validity to ensure the process is adequately covered;

- (9) Capability and Breach of Contract: Tenderers that do not have the capability of undertaking this enquiry in terms of the requirements of the contract or have been in breach of contract previously will not be considered.

20. APPEALS

1. Definitions

The following terms shall be interpreted as indicated:

- 1.1 "Closing time" means the date and hour specified in the bidding documents for the receipt of bids.
- 1.2 "Contract" means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
- 1.3 "Contract price" means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations.
- 1.4 "Corrupt practice" means the offering, giving, receiving, or soliciting of anything of value to influence the action of a public official in the procurement process or in contract execution.
- 1.5 "Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
- 1.6 "Country of origin" means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
- 1.7 "Day" means calendar day.
- 1.8 "Delivery" means delivery in compliance of the conditions of the contract or order.
- 1.9 "Delivery ex stock" means immediate delivery directly from stock actually on hand.
- 1.10 "Delivery into consignee store or to his site" means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the goods are so delivered and a valid receipt is obtained.
- 1.11 "Dumping" occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the RSA.
- 1.12 "Force majeure" means an event beyond the control of the supplier and not involving the supplier's fault or negligence and not foreseeable. Such events may include, but is not restricted to, acts of the purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.
- 1.13 "Fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of any bidder, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the bidder of the benefits of free and open competition.
- 1.14 "GCC" means the General Conditions of Contract.
- 1.15 "Goods" means all of the equipment, machinery, and/or other materials that the supplier is required to supply to the purchaser under the contract.

- 1.16 "Imported content" means that portion of the bidding price represented by the cost of components, parts or materials which have been or are still to be imported (whether by the supplier or his subcontractors) and which costs are inclusive of the costs abroad, plus freight and other direct importation costs such as landing costs, dock dues, import duty, sales duty or other similar tax or duty at the South African place of entry as well as transportation and handling charges to the factory in the Republic where the goods covered by the bid will be manufactured.
- 1.17 "Local content" means that portion of the bidding price, which is not included in the imported content provided that local manufacture does take place.
- 1.18 "Manufacture" means the production of products in a factory using labour, materials, components and machinery and includes other related value-adding activities.
- 1.19 "Order" means an official written order issued for the supply of goods or works or the rendering of a service.
- 1.20 "Project site," where applicable, means the place indicated in bidding documents.
- 1.21 "Purchaser" means the organization purchasing the goods.
- 1.22 "Republic" means the Republic of South Africa.
- 1.23 "SCC" means the Special Conditions of Contract.
- 1.24 "Services" means those functional services ancillary to the supply of the goods, such as transportation and any other incidental services, such as installation, commissioning, provision of technical assistance, training, catering, gardening, security, maintenance and other such obligations of the supplier covered under the contract.
- 1.25 "Supplier" means the successful bidder who is awarded the contract to maintain and administer the required and specified service(s) to the State.
- 1.26 "Tort" means in breach of contract.
- 1.27 "Turnkey" means a procurement process where one service provider assumes total responsibility for all aspects of the project and delivers the full end product / service required by the contract.
- 1.28 "Written" or "in writing" means hand-written in ink or any form of electronic or mechanical writing.

2. Application

- 2.1 These general conditions are applicable to all bids, contracts and orders including bids for functional and professional services (excluding professional services related to the building and construction industry), sales, hiring, letting and the granting or acquiring of rights, but excluding immovable property, unless otherwise indicated in the bidding documents.
- 2.2 Where applicable, special conditions of contract are also laid down to cover specific goods, services or works.
- 2.3 Where such special conditions of contract are in conflict with these general conditions, the special conditions shall apply.

3. General

- 3.1 Unless otherwise indicated in the bidding documents, the purchaser shall not be liable for any expense incurred in the preparation and submission of a bid. Where applicable a non-refundable fee for documents may be charged.
- 3.2 Invitations to bid are usually published in locally distributed news media and on the municipality/municipal entity website.

4. Standards

- 4.1 The goods supplied shall conform to the standards mentioned in the bidding documents and specifications.

5. Use of contract documents and information inspection

- 5.1 The supplier shall not, without the purchaser's prior written consent, disclose the contract, or any provision thereof, or any specification, plan, drawing, pattern, sample, or information furnished by or on behalf of the purchaser in connection therewith, to any person other than a person employed by the supplier in the performance of the contract. Disclosure to any such employed person shall be made in confidence and shall extend only so far as may be necessary for purposes of such performance.
- 5.2 The supplier shall not, without the purchaser's prior written consent, make use of any document or information mentioned in GCC clause 5.1 except for purposes of performing the contract.
- 5.3 Any document, other than the contract itself mentioned in GCC clause 5.1 shall remain the property of the purchaser and shall be returned (all copies) to the purchaser on completion of the supplier's performance under the contract if so required by the purchaser.
- 5.4 The supplier shall permit the purchaser to inspect the supplier's records relating to the performance of the supplier and to have them audited by auditors appointed by the purchaser, if so required by the purchaser.

6. Patent Rights

- 6.1 The supplier shall indemnify the purchaser against all third-party claims of infringement of patent, trademark, or industrial design rights arising from use of the goods or any part thereof by the purchaser.
- 6.2 When a supplier developed documentation / projects for the municipality / municipal entity, the intellectual, copy and patent rights or ownership of such documents or projects will vest in the municipality / municipal entity.

7. Performance security

- 7.1 Within thirty (30) days of receipt of the notification of contract award, the successful bidder shall furnish to the purchaser the performance security of the [amount specified in SCC](#).
- 7.2 The proceeds of the performance security shall be payable to the purchaser as compensation for any loss resulting from the supplier's failure to complete his obligations under the contract.
- 7.3 The performance security shall be denominated in the currency of the contract or in a freely convertible currency acceptable to the purchaser and shall be in one of the following forms:
- (a) a bank guarantee or an irrevocable letter of credit issued by a reputable bank located in the purchaser's country or abroad, acceptable to the purchaser, in the form provided in the bidding documents or another form acceptable to the purchaser; or
 - (b) a cashier's or certified cheque.
- 7.4 The performance security will be discharged by the purchaser and returned to the supplier not later than thirty (30) days following the date of completion of the supplier's performance obligations under the contract, including any warranty obligations, [unless otherwise specified](#).

8. Inspections, tests and analyses

- 8.1 All pre-bidding testing will be for the account of the bidder.
- 8.2 If it is a bid condition that goods to be produced or services to be rendered should at any stage be subject to inspections, tests and analyses, the bidder or contractor's premises shall be open, at all reasonable hours, for inspection by a representative of the purchaser or organization acting on behalf of the purchaser.

- 8.3 If there are no inspection requirements indicated in the bidding documents and no mention is made in the contract, but during the contract period it is decided that inspections shall be carried out, the purchaser shall itself make the necessary arrangements, including payment arrangements with the testing authority concerned.

- 8.4 If the inspections, tests and analyses referred to in clauses 8.2 and 8.3 show the goods to be in accordance with the contract requirements, the cost of the inspections, tests and analyses shall be defrayed by the purchaser.

- 8.5 Where the goods or services referred to in clauses 8.2 and 8.3 do not comply with the contract requirements, irrespective of whether such goods or services are accepted or not, the cost in connection with these inspections, tests or analyses shall be defrayed by the supplier.

- 8.6 Goods and services which are referred to in clauses 8.2 and 8.3 and which do not comply with the contract requirements may be rejected.

- 8.7 Any contract goods may on or after delivery be inspected, tested or analysed and may be rejected if found not to comply with the requirements of the contract. Such rejected goods shall be held at the cost and risk of the supplier who shall, when called upon, remove them immediately at his own cost and forthwith substitute them with goods, which do comply with the requirements of the contract. Failing such removal the rejected goods shall be returned at the suppliers cost and risk. Should the supplier fail to provide the substitute goods forthwith, the purchaser may, without giving the supplier further opportunity to substitute the rejected goods, purchase such goods as may be necessary at the expense of the supplier.

- 8.8 The provisions of clauses 8.4 to 8.7 shall not prejudice the right of the purchaser to cancel the contract on account of a breach of the conditions thereof, or to act in terms of Clause 22 of GCC.

9. Packing

- 9.1 The supplier shall provide such packing of the goods as is required to prevent their damage or deterioration during transit to their final destination, as indicated in the contract. The packing shall be sufficient to withstand, without limitation, rough handling during transit and exposure to extreme temperatures, salt and precipitation during transit, and open storage. Packing, case size weights shall take into consideration, where appropriate, the remoteness of the goods' final destination and the absence of heavy handling facilities at all points in transit.
- 9.2 The packing, marking, and documentation within and outside the packages shall comply strictly with such special requirements as shall be expressly provided for in the contract, [including additional requirements](#), if any, and in any subsequent instructions ordered by the purchaser.

10. Delivery and documents

- 10.1 Delivery of the goods and arrangements for shipping and clearance obligations, shall be made by the supplier in accordance with the terms [specified in the contract](#).

11. Insurance

- 11.1 The goods supplied under the contract shall be fully insured in a freely convertible currency against loss or damage incidental to manufacture or acquisition, transportation, storage and delivery [in the manner specified](#).

12. Transportation

- 12.1 Should a price other than an all-inclusive delivered price be required, [this shall be specified](#).

13. Incidental Services

13.1 The supplier may be required to provide any or all of the following services, **including additional services**, if any:

- (a) performance or supervision of on-site assembly and/or commissioning of the supplied goods;
- (b) furnishing of tools required for assembly and/or maintenance of the supplied goods;
- (c) furnishing of a detailed operations and maintenance manual for each appropriate unit of the supplied goods;
- (d) performance or supervision or maintenance and/or repair of the supplied goods, for a period of time agreed by the parties, provided that this service shall not relieve the supplier of any warranty obligations under this contract; and
- (e) training of the purchaser's personnel, at the supplier's plant and/or on-site, in assembly, start-up, operation, maintenance, and/or repair of the supplied goods.

13.2 Prices charged by the supplier for incidental services, if not included in the contract price for the goods, shall be agreed upon in advance by the parties and shall not exceed the prevailing rates charged to other parties by the supplier for similar services.

14. Spare parts

14.1 **As specified**, the supplier may be required to provide any or all of the following materials, notifications, and information pertaining to spare parts manufactured or distributed by the supplier:

- (a) such spare parts as the purchaser may elect to purchase from the supplier, provided that this election shall not relieve the supplier of any warranty obligations under the contract; and;
- (b) in the event of termination of production of the spare parts:
 - (i) advance notification to the purchaser of the pending termination, in sufficient time to permit the purchaser to procure needed requirements; and
 - (ii) following such termination, furnishing at no cost to the purchaser, the blueprints, drawings, and specifications of the spare parts, if requested.

15. Warranty

15.1 The supplier warrants that the goods supplied under the contract are new, unused, of the most recent or current models, and that they incorporate all recent improvements in design and materials unless provided otherwise in the contract. The supplier further warrants that all goods supplied under this contract shall have no defect, arising from design, materials, or workmanship (except when the design and/or material is required by the purchaser's specifications) or from any act or omission of the supplier, that may develop under normal use of the supplied goods in the conditions prevailing in the country of final destination.

15.2 This warranty shall remain valid for twelve (12) months after the goods, or any portion thereof as the case may be, have been delivered to and accepted at the final destination indicated in the contract, or for eighteen (18) months after the date of shipment from the port or place of loading in the source country, whichever period concludes earlier, **unless specified otherwise**.

15.3 The purchaser shall promptly notify the supplier in writing of any claims arising under this warranty.

15.4 Upon receipt of such notice, the supplier shall, **within the period specified** and with all reasonable speed, repair or replace the defective goods or parts thereof, without costs to the purchaser.

15.5 If the supplier, having been notified, fails to remedy the defect(s) **within the period specified**, the purchaser may proceed to take such remedial action as may be necessary, at the supplier's risk and expense and without prejudice to any other rights which the purchaser may have against the supplier under the contract.

16. Payment

16.1 The method and conditions of payment to be made to the supplier under this contract **shall be specified**.

16.2 The supplier shall furnish the purchaser with an invoice accompanied by a copy of the delivery note and upon fulfilment of other obligations stipulated in the contract.

16.3 Payments shall be made promptly by the purchaser, but in no case later than thirty (30) days after submission of an invoice or claim by the supplier.

16.4 Payment will be made in Rand **unless otherwise stipulated**.

17. Prices

17.1 Prices charged by the supplier for goods delivered and services performed under the contract shall not vary from the prices quoted by the supplier in his bid, with the exception of any **price adjustments authorized** or in the purchaser's request for bid validity extension, as the case may be.

18. Variation orders

18.1 In cases where the estimated value of the envisaged changes in purchase does not vary more than 15% of the total value of the original contract, the contractor may be instructed to deliver the goods or render the services as such. In cases of measurable quantities, the contractor may be approached to reduce the unit price, and such offers may be accepted provided that there is no escalation in price.

19. Assignment

19.1 The supplier shall not assign, in whole or in part, its obligations to perform under the contract, except with the purchaser's prior written consent.

20. Subcontracts

20.1 The supplier shall notify the purchaser in writing of all subcontracts awarded under this contracts if not already specified in the bid. Such notification, in the original bid or later, shall not relieve the supplier from any liability or obligation under the contract.

21. Delays in the supplier's performance

21.1 Delivery of the goods and performance of services shall be made by the supplier in accordance with the **time schedule prescribed** by the purchaser in the contract.

21.2 If at any time during performance of the contract, the supplier or its subcontractor(s) should encounter conditions impeding timely delivery of the goods and performance of services, the supplier shall promptly notify the purchaser in writing of the fact of the delay, its likely duration and its cause(s). As soon as practicable after receipt of the supplier's notice, the purchaser shall evaluate the situation and may at his discretion extend the supplier's time for performance, with or without the imposition of penalties, in which case the extension shall be ratified by the parties by amendment of contract.

21.3 The right is reserved to procure outside of the contract small quantities or to have minor essential services executed if an emergency arises, the supplier's point of supply is not situated at or near the place where the goods are required, or the supplier's services are not readily available.

- 21.4 Except as provided under GCC Clause 25, a delay by the supplier in the performance of its delivery obligations shall render the supplier liable to the imposition of penalties, pursuant to GCC Clause 22, unless an extension of time is agreed upon pursuant to GCC Clause 22.2 without the application of penalties.
- 21.5 Upon any delay beyond the delivery period in the case of a goods contract, the purchaser shall, without cancelling the contract, be entitled to purchase goods of a similar quality and up to the same quantity in substitution of the goods not supplied in conformity with the contract and to return any goods delivered later at the supplier's expense and risk, or to cancel the contract and buy such goods as may be required to complete the contract and without prejudice to his other rights, be entitled to claim damages from the supplier.
- 22. Penalties**
- 22.1 Subject to GCC Clause 25, if the supplier fails to deliver any or all of the goods or to perform the services within the period(s) specified in the contract, the purchaser shall, without prejudice to its other remedies under the contract, deduct from the contract price, as a penalty, a sum calculated on the delivered price of the delayed goods or unperformed services using the current prime interest rate calculated for each day of the delay until actual delivery or performance. The purchaser may also consider termination of the contract pursuant to GCC Clause 23.
- 23. Termination for default**
- 23.1 The purchaser, without prejudice to any other remedy for breach of contract, by written notice of default sent to the supplier, may terminate this contract in whole or in part:
- if the supplier fails to deliver any or all of the goods within the period(s) specified in the contract, or within any extension thereof granted by the purchaser pursuant to GCC Clause 21.2;
 - if the supplier fails to perform any other obligation(s) under the contract; or
 - if the supplier, in the judgement of the purchaser, has engaged in corrupt or fraudulent practices in competing for or in executing the contract.
- 23.2 In the event the purchaser terminates the contract in whole or in part, the purchaser may procure, upon such terms and in such manner, as it deems appropriate, goods, works or services similar to those undelivered, and the supplier shall be liable to the purchaser for any excess costs for such similar goods, works or services. However, the supplier shall continue performance of the contract to the extent not terminated.
- 23.3 Where the purchaser terminates the contract in whole or in part, the purchaser may decide to impose a restriction penalty on the supplier by prohibiting such supplier from doing business with the public sector for a period not exceeding 10 years.
- 23.4 If a purchaser intends imposing a restriction on a supplier or any person associated with the supplier, the supplier will be allowed a time period of not more than fourteen (14) days to provide reasons why the envisaged restriction should not be imposed. Should the supplier fail to respond within the stipulated fourteen (14) days the purchaser may regard the supplier as having no objection and proceed with the restriction.
- 23.5 Any restriction imposed on any person by the purchaser will, at the discretion of the purchaser, also be applicable to any other enterprise or any partner, manager, director or other person who wholly or partly exercises or exercised or may exercise control over the enterprise of the first-mentioned person, and with which enterprise or person the first-mentioned person, is or was in the opinion of the purchaser actively associated.
- 23.6 If a restriction is imposed, the purchaser must, within five (5) working days of such imposition, furnish the National Treasury, with the following information:
- the name and address of the supplier and / or person restricted by the purchaser;
 - the date of commencement of the restriction
 - the period of restriction; and
 - the reasons for the restriction.
- These details will be loaded in the National Treasury's central database of suppliers or persons prohibited from doing business with the public sector.
- 23.7 If a court of law convicts a person of an offence as contemplated in sections 12 or 13 of the Prevention and Combating of Corrupt Activities Act, No. 12 of 2004, the court may also rule that such person's name be endorsed on the Register for Tender Defaulters. When a person's name has been endorsed on the Register, the person will be prohibited from doing business with the public sector for a period not less than five years and not more than 10 years. The National Treasury is empowered to determine the period of restriction and each case will be dealt with on its own merits. According to section 32 of the Act the Register must be open to the public. The Register can be perused on the National Treasury website.
- 24. Antidumping and countervailing duties and rights**
- 24.1 When, after the date of bid, provisional payments are required, or anti-dumping or countervailing duties are imposed, or the amount of a provisional payment or anti-dumping or countervailing right is increased in respect of any dumped or subsidized import, the State is not liable for any amount so required or imposed, or for the amount of any such increase. When, after the said date, such a provisional payment is no longer required or any such anti-dumping or countervailing right is abolished, or where the amount of such provisional payment or any such right is reduced, any such favourable difference shall on demand be paid forthwith by the supplier to the purchaser or the purchaser may deduct such amounts from moneys (if any) which may otherwise be due to the supplier in regard to goods or services which he delivered or rendered, or is to deliver or render in terms of the contract or any other contract or any other amount which may be due to him.
- 25. Force Majeure**
- 25.1 Notwithstanding the provisions of GCC Clauses 22 and 23, the supplier shall not be liable for forfeiture of its performance security, damages, or termination for default if and to the extent that his delay in performance or other failure to perform his obligations under the contract is the result of an event of force majeure.
- 25.2 If a force majeure situation arises, the supplier shall promptly notify the purchaser in writing of such condition and the cause thereof. Unless otherwise directed by the purchaser in writing, the supplier shall continue to perform its obligations under the contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the force majeure event.
- 26. Termination for insolvency**
- 26.1 The purchaser may at any time terminate the contract by giving written notice to the supplier if the supplier becomes bankrupt or otherwise insolvent. In this event, termination will be without compensation to the supplier, provided that such termination will not prejudice or affect any right of action or remedy, which has accrued or will accrue thereafter to the purchaser.

27. Settlement of Disputes

- 27.1 If any dispute or difference of any kind whatsoever arises between the purchaser and the supplier in connection with or arising out of the contract, the parties shall make every effort to resolve amicably such dispute or difference by mutual consultation.
- 27.2 If, after thirty (30) days, the parties have failed to resolve their dispute or difference by such mutual consultation, then either the purchaser or the supplier may give notice to the other party of his intention to commence with mediation. No mediation in respect of this matter may be commenced unless such notice is given to the other party.
- 27.3 Should it not be possible to settle a dispute by means of mediation, it may be settled in a South African court of law.
- 27.4 Notwithstanding any reference to mediation and/or court proceedings herein,
- (a) the parties shall continue to perform their respective obligations under the contract unless they otherwise agree; and
 - (b) the purchaser shall pay the supplier any monies due the supplier for goods delivered and / or services rendered according to the prescripts of the contract.

28. Limitation of Liability

- 28.1 Except in cases of criminal negligence or wilful misconduct, and in the case of infringement pursuant to Clause 6;
- (a) the supplier shall not be liable to the purchaser, whether in contract, tort, or otherwise, for any indirect or consequential loss or damage, loss of use, loss of production, or loss of profits or interest costs, provided that this exclusion shall not apply to any obligation of the supplier to pay penalties and/or damages to the purchaser; and
 - (b) the aggregate liability of the supplier to the purchaser, whether under the contract, in tort or otherwise, shall not exceed the total contract price, provided that this limitation shall not apply to the cost of repairing or replacing defective equipment.

29. Governing language

- 29.1 The contract shall be written in English. All correspondence and other documents pertaining to the contract that is exchanged by the parties shall also be written in English.

30. Applicable law

- 30.1 The contract shall be interpreted in accordance with South African laws, unless otherwise specified.

31. Notices

- 31.1 Every written acceptance of a bid shall be posted to the supplier concerned by registered or certified mail and any other notice to him shall be posted by ordinary mail to the address furnished in his bid or to the address notified later by him in writing and such posting shall be deemed to be proper service of such notice.
- 31.2 The time mentioned in the contract documents for performing any act after such aforesaid notice has been given, shall be reckoned from the date of posting of such notice.

32. Taxes and duties

- 32.1 A foreign supplier shall be entirely responsible for all taxes, stamp duties, license fees, and other such levies imposed outside the purchaser's country.
- 32.2 A local supplier shall be entirely responsible for all taxes, duties, license fees, etc., incurred until delivery of the contracted goods to the purchaser.
- 32.3 No contract shall be concluded with any bidder whose tax matters are not in order. Prior to the award of a bid SARS must have certified that the tax matters of the preferred bidder are in order.
- 32.4 No contract shall be concluded with any bidder whose municipal rates and taxes and municipal services charges are in arrears.

33. Transfer of Contracts

- 33.1 The contractor shall not abandon, transfer, cede assign or sublet a contract or part thereof without the written permission of the purchaser.

34. Amendment of contracts

- 34.1 No agreement to amend or vary a contract or order or the conditions, stipulations or provisions thereof shall be valid and of any force unless such agreement to amend or vary is entered into in writing and signed by the contracting parties. Any waiver of the requirement that the agreement to amend or vary shall be in writing, shall also be in writing.

35. Prohibition of restrictive practices

- 35.1 In terms of section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, an agreement between, or concerted practice by, firms, or a decision by an association of firms, is prohibited if it is between parties in a horizontal relationship and if a bidder(s) is / are or a contractor(s) was / were involved in collusive bidding.
- 35.2 If a bidder(s) or contractor(s) based on reasonable grounds or evidence obtained by the purchaser has / have engaged in the restrictive practice referred to above, the purchaser may refer the matter to the Competition Commission for investigation and possible imposition of administrative penalties as contemplated in section 59 of the Competition Act No 89 Of 1998.
- 35.3 If a bidder(s) or contractor(s) has / have been found guilty by the Competition Commission of the restrictive practice referred to above, the purchaser may, in addition and without prejudice to any other remedy provided for, invalidate the bid(s) for such item(s) offered, and / or terminate the contract in whole or part, and / or restrict the bidder(s) or contractor(s) from conducting business with the public sector for a period not exceeding ten (10) years and / or claim damages from the bidder(s) or contractor(s) concerned.

SECTION 6: SPECIAL / ADDITIONAL CONDITIONS OF CONTRACT

The **Conditions of Contract** make reference to the **Special Conditions of Contract (SSC)** for details that apply specifically to this bid. The **Special Conditions of Contract** shall have precedence in the interpretation of any ambiguity or inconsistency between it and the **Conditions of Contract**.

Each item below is cross-referenced to the clause in the **Conditions of Contract** to which it mainly applies.

SCC 1.2 CONTRACT

Performance under this contract will be within 15 days of the placement of an official order.

SCC 7.1 PERFORMANCE SECURITY

The liability of the Performance Security shall be Nil.

SCC 10.1 DELIVERY AND DOCUMENTS

All spares supplied shall be delivered to eThekweni Electricity HV Substations, address 11 Electron Road, Springfield, and Durban, and 4001 or to be delivered on site within eThekweni Municipality area of supply, the exact location will be indicated by the Clerk of Works or Engineer: HV Substations

SCC 11.1 INSURANCE

The Contractor agrees that he has taken out and will maintain adequate insurance cover in respect to:

- a) Loss or damage of property.
- b) Injury to persons.
- c) Public liability; and
- d) All risk of injury or death arising out of their employment, of all persons employed by him.

The Contractor agrees to comply with the provisions of the Compensation for Occupational Injuries and Diseases Act, 1993, in respect of all of his staff.

SCC 14.1 SPARE PARTS

Refer to section 7.8 of the specifications

SCC 16.1 PAYMENT

The Contractor shall submit to the Department concerned a detailed account which shall reflect the identifying number of each item / service. Payment will be made on this account when checked and substantiated by the authorised official.

Payment for goods received and accepted by the Municipality shall be made no later than 30 days after submission of invoice or claim, provided however that all the terms of the contract are duly complied with.

Payment will be made only to the supplier. Factoring arrangements will not be accepted.

SCC 17 **PRICES**

Prices are fixed for the duration of the contract, or for the 12-month period(s) as specified on the Official Tender Form.

SCC 22.1 **PENALTIES**

Replace this clause with the following:

“If the supplier fails to deliver any or all of the goods or to perform the services within the period(s) specified in the contract, the purchaser shall, without prejudice to its other remedies under the contract, deduct from the contract price (as a penalty):

- A penalty of 5% of the order value for each day delivery is delayed.

The purchaser may also consider termination of the contract pursuant to GCC Clause 23.”

ADDITIONAL CONDITIONS OF CONTRACT

ACC1 PERFORMANCE MONITORING & ASSESSMENT OF SERVICE PROVIDERS

For contract awards that are greater than R10m, the Contractor shall be subjected to "Performance Monitoring" assessments in terms of the applicable Section of the Council's current Supply Chain Management Policy.

ACC2 QUALITY OF PRODUCTS

No inferior products will be accepted under this enquiry.

Should there be any cause for complaint against the standard of service or quality of products offered which is not resolved within a period of 10 working days, the Municipality reserves the right to cancel the contract after serving one month's notice, in writing, to the supplier involved. Should such notice be given, the supplier shall nevertheless be obliged to perform the duties covered by the contract up to the date of expiration of the period of notice.

ACC3 SATISFACTORY PERFORMANCE

The supplier shall employ for the purpose of this contract only such personnel as are careful and competent and the Municipality shall be at liberty to object to and require the supplier to remove from the job forthwith any person, including supervisory staff, employed by the supplier who, in the opinion of the Municipality, misconducts himself/herself or is incompetent or negligent in the proper performance of his/her duties and such person shall not again be employed upon this contract without the permission of the Municipality.

ACC4 OCCUPATIONAL INJURIES AND DISEASES ACT

This act replaces the Workmen's Compensation Act:

The supplier shall, before commencement of work, produce documentary proof to the Deputy Municipal Manager, Treasury: Finance that he has complied in all respects with the provisions of the Occupational Injuries and Diseases Act. The supplier undertakes that he/she will perform and comply with all provisions of the Occupational Injuries and Diseases Act and more particularly that he/she will render all returns and pay all assessments for which he/she is liable in terms of such Act.

ACC5 DAMAGE TO PERSONS AND PROPERTY

- (1) The supplier **shall** indemnify and keep indemnified the Council against any claim for death, injury, damage or loss to any person or property whatsoever in respect thereof or in relation thereto.
- (2) The supplier enters into this contract as an independent contractor and shall be solely liable in respect of any claim for death, injury, damage or loss to any person or property whatsoever in respect thereof or in relation thereto.

ACC6 ESTIMATED QUANTITIES

The quantities stated in Section 8 are applicable for evaluation purposes only. The final quantity of goods and services required shall vary, depending on the total number of actual instances a service/goods will be required over the Contract Period. The rates tendered shall be applicable, irrespective of the total quantity of goods and services procured over the contract duration.

ACC7 SERVICE PROVIDER OFFICE REQUIREMENTS

The service provider must have, for the duration of the contract, a local presence (within the geographical eThekwini boundary).

ACC9 EMPOWERMENT REQUIREMENT

eThekwini municipality has, in the SCM policy, made accommodation for subcontracting to designated groups, where possible, which are defined as follows:

It is a requirement of contract that a minimum of 30% of the work must be sub-contracted to the entities that are 51% or more black owned.

ACC10 EMPOWERMENT REQUIREMENT: CPG PENALTY

Failure to meet the contract participation goal shall result in the application of penalties, payable in Rands, equal to 30% of daily rate to be paid to CPG subcontractor, until such time the contract participation goal is met.

ACC11 PRECAUTIONARY MEASURES

- The Specialists and Electricians of successful bidder(s) to attend and pass eThekwini Electricity's safety rules course.
- The Contractor shall, at his own expense, take all precautions requisite for the protection of life and property on, and about, and shall indemnify, and keep indemnified, eThekwini Electricity against losses, claims, demands, proceedings, damages, costs, charges and expenses of whatsoever nature, howsoever arising, in respect of injury to, or death or loss of, or damage to, any property or person at any time during the currency of the contract.

ACC18 ADHERENCE TO SECURITY ARRANGEMENTS AND SITE REGULATIONS

The Contractor shall be obliged to abide by all security arrangements and site regulations in force, at any substation he is required to work at. The Contractor shall similarly ensure that his staff abide by such regulations and arrangements.

ACC19 CONDITIONS FOR CANCELLATION OF CONTRACT

Should eThekwini Electricity be of the opinion that the Contractor has failed to carry out any of its obligations in term of this contract, or if eThekwini Electricity, in its absolute discretion, is in any way dissatisfied with the goods or service rendered, then eThekwini Electricity may give the Contractor notice, in writing, of such complaints and, if the situation is not rectified within seven (7) days from the date of such notice, eThekwini Electricity may forthwith cancel this contract.

ACT1. CONTRACT PARTICIPATION GOALS (CPG)

The tenderer will be required to sub-contract a minimum of 30% of the contract value to 51% Black owned enterprises:

A CPG implementation Plan must be submitted together with this tender, demonstrating how the above CPG will be achieved.

ACC20 EMPOWERMENT REQUIREMENT: CPG PENALTY

Failure to meet the contract participation goal shall result in the application of penalties, at the discretion of the Employer, payable in Rands, equal to one and a half times the difference between the tendered and achieved participation goals multiplied by the Award Value and divided by one hundred.

SECTION 7: SCOPE AND SPECIFICATION OF REQUIRED SUPPLY / SERVICES

Scope of Supply / Services

7.1. Background

The **275 kV** and **132 kV circuit breakers** form an essential part of the electrical transmission network, playing a critical role in the reliable and secure operation of the grid. These circuit breakers are responsible for ensuring the protection of the electrical network by automatically interrupting the flow of current during fault conditions, thereby preventing damage to equipment, protecting personnel, and maintaining the stability of the grid. These devices are deployed in critical infrastructure, where uninterrupted and stable power supply is crucial for both residential and industrial sectors.

The **SF6 circuit breakers** and **oil circuit breakers** specifically, handle high-voltage electrical currents that, if improperly managed, can lead to catastrophic failures. SF6 (Sulfur Hexafluoride) circuit breakers use SF6 gas to extinguish electrical arcs during fault conditions, while oil circuit breakers rely on oil as an insulating medium to quench the arcs. Both types are subjected to harsh operating environments and require regular maintenance, timely repairs, and proactive management to ensure their optimal performance.

7.2. Strategic importance

The strategic importance of this tender lies in ensuring that these critical circuit breakers are in optimum condition at all times. Failing to do so may have devastating consequences on the electrical network and the wider economy, with far-reaching impacts:

- **System Reliability:** Circuit breakers are the first line of defense against faults, such as short circuits and overloads. If a breaker fails to operate correctly, the entire transmission network can be compromised, leading to unplanned outages. These outages can disrupt power to thousands of customers, causing inconvenience and potential economic losses for businesses and industries that rely on continuous power supply.
- **Equipment Protection:** A malfunctioning circuit breaker can result in significant damage to costly equipment downstream, including transformers, generators, and transmission lines. Repairing or replacing damaged equipment is far more expensive than the cost of regular maintenance. Furthermore, without proper circuit breaker performance, the risk of further electrical faults increases, compounding the potential for system-wide damage.
- **Safety Risks:** Circuit breakers are designed to protect not only the electrical network but also personnel working with high-voltage equipment. Faulty or improperly maintained breakers may fail to isolate faulty sections of the network, exposing workers to electrical hazards. The risk of injury or fatality due to electrical faults increases if these devices are not maintained in optimal working condition.

- **Environmental Impact:** SF6 circuit breakers, if not properly maintained, can leak SF6 gas into the atmosphere. SF6 is a potent greenhouse gas, and leaks can contribute to environmental damage. Oil leaks from high-voltage circuit breakers can have wide-ranging environmental impacts, including contamination of soil, water, and air, as well as harm to wildlife and ecosystems.

7.3. Objectives

Given these critical functions and the potential risks associated with faulty or poorly maintained circuit breakers, the importance of obtaining a highly qualified service provider cannot be overstated. The service provider will be responsible for the regular inspection, testing, maintenance, and emergency repair of both SF6 and oil circuit breakers. By ensuring the continuous, reliable, and safe operation of these breakers, the service provider will contribute to the long-term stability and sustainability of the transmission network, preventing catastrophic consequences such as prolonged power outages, equipment failures, safety incidents, and environmental harm.

The specification requires OEM/ OEM approved service providers for maintenance of ABB, Actom, Siemens and Areva high voltage (275 kV- 132 kV) Circuit breakers according to OEM and eThekweni Electricity maintenance code of practice for a period of thirty-six (36) months on an as and when required basis.

7.4. Technical specification

The specification is seeking offers from service providers for service and maintenance of 132kV, and 275 kV Outdoor Circuit breakers. The scope of work is including the required maintenance team and tools in order to carry out the different types of maintenance and repairs. The service provider shall also provide training for internal eThekweni Electricity staff on CB maintenance during the 36 month period of a contract on an as and when required basis

Three methods of maintenance will be utilised in this enquiry, Namely:

- Conditional assessment
- Non-tactical maintenance
- Tactical Maintenance

NB: Record all results on test report

7.5. Condition Assessment

The following condition assessment points shall be followed for all the different voltage levels circuit breakers:

- a) The Tenderer shall undertake the initial condition assessment on the selected circuit breakers maintenance is to be carried out on
- b) The condition assessment shall include but not limited, the following.
 - audit and confirmation of all necessary supporting documentation (such manuals, drawings, etc) required for effective switchgear maintenance
 - visual inspection/assessment of selected installed switchgear

- c) At the completion of the initial condition assessment, the Tenderer shall prepare and submit a report comprising but not limited to, the following:
- the present condition of all equipment assessed.
 - the recommended immediate remedial action plans if applicable.
 - the recommended switchgear periodic inspections and frequencies basis.
 - the recommended most appropriate *tactical maintenance* programs plan
 - the recommended mid-life overhaul plans; and
 - the recommended spares required to meet the performance requirements of this enquiry.
- d) The recommendations in the initial condition assessment report shall be approved, accepted, modified or rejected by the Senior Manager: HV Substations; and signed off by both the tenderer and the senior manager or his duly representative before commencement of any work
- e) The maintenance and repairs will be done in accordance with the scope of work agreed to by the tenderer and HV Substations' Senior Manager or his duly authorised representative

7.6. Scope of work breakdown

The Tactical and non-tactical maintenance of the breakers will be sectioned as follows:

- A. 275 and 132 kV SF6 gas circuit breakers with spring mechanism
- B. 275 and 132 kV SF6 gas circuit breakers with hydraulic mechanism
- C. 132 kV Oil Circuit Breaker

The recommended services to be performed/provided includes but not limited to:

7.6.1. SF6 GAS CIRCUIT BREAKERS WITH SPRING MECHANISM

7.6.1.1. Non-tactical Maintenance

- Check the general conditions of the equipment (corrosion, loose parts, damage of porcelain...)
- Check ventilation ports and vents
- Check the anti-condensation heating and settings
- Check the SF6 pressure and top up if necessary
- Check for leakage of hydraulic piston inside mechanism
- Read and record the operation counter figure

7.6.1.2. Tactical Maintenance

- Check the cable connections and tightness of terminal screws
- Check the connecting linkage
- Check the screwed and bolted connections
- Check the SF6 dew point (less than -10°C)
- Check the SF6 air content (less than 2%)
- Check the SF6 acid content (less than 10 ppmG)
- Check the function of the electric control circuits

- Check the charging time and motor current of the closing spring
- Record the operation time and movement of the circuit breaker ON/OFF operation
- Check the manual operation and interlocks
- Check the anti-pumping system
- Check the function of SF6 warnings and alarms
- Check arcing contacts and replace if necessary
- Check moving contacts and replace if necessary
- Replace all seals, gaskets and expansion bolts
- Replace the molecular filter bag
- Circuit breaker pole:
 - Measure of main contacts resistance (NB)
 - Change the gas seals of poles and check the condition of interrupting chambers
 - Implement main improvement as given by the manufacturer
 - Check or replace parts of main contacts
 - Check or replace operating rods of supporting columns
 - Check or replace breaking parts
 - Replace signalling contact switches
 - Grease the operating rod

7.6.2. SF6 GAS CIRCUIT BREAKERS WITH HYDRAULIC MECHANISM

7.6.2.1. Non-tactical Maintenance

- Read and record the operation counter figures
- Check general condition of equipment (corrosion, pollution, heating marks...)
- Check the condition of air vents and permanent heating
- Check tightening of non-pressurized elements (frame, cubicle)
- Check the low voltage terminal blocks tightening (first, six months after commissioning)
- Check relay operation in operating mechanism cubicle
- Check locking and alarm functions
- Inspection of supporting columns and main chambers insulators

7.6.2.2. Tactical Maintenance

- Check SF6 gas rated pressure of each pole
- Check quality of SF6 gas (according to operating conditions of the circuit breaker)
- Measure of main contacts resistance
- Change the gas seals of poles and check the condition of interrupting chambers
- Implement main improvement as given by the manufacturer
- Check or replace parts of main contacts
- Check or replace operating rods of supporting columns
- Check or replace breaking parts
- Replace signaling contact switches
- Grease the operating rod
- Read and record the pump starts counter figures
- Check general tightness of the hydraulic system
- Check receiver oil level
- Change the oil filter

- Change oil indicator and LP flexible tube of control cubicle (for CI only)
- Check or replace all HP flexible pipes (for CIN only)
- Implement main improvement brought by the manufacturer
- Change the hydraulic oil
- Change the static and dynamic seals of driving system
- Change nitrogen accumulators and safety valves
- Carry out the accumulator high pressure test (according to local laws)
- Check or replace door seal or cover seal (cubicle/reinflation group)

7.6.3. 132 kV Oil Circuit breakers

7.6.3.1. Non-tactical Maintenance

- Record the operation number of the circuit breaker
- Check the general conditions of the equipment: visual aspect (corrosion, pollution, heating marks, painting)
- Check the conditions of air vents and heating of operating mechanism*
- Check the oil level of circuit breaker poles*
- Check the tightness of non-pressurized elements (frame, cubicle)
- Check the tightness of LV terminals
- Check the good operation of relays
- Check the closing and alarm functions
- Clean and lubricate (if necessary) each operating spring mechanism

7.6.3.2. Tactical Maintenance

- Drain off the oils and reduce pressure to zero
- Tilt top to one side and remove fixed contacts and contact
- Check arcing ring and tabules for burning - replace if necessary
- Check fixed contact pieces for pitting, burning, etc. Do
- When replacing contact pieces and tabules, check that they and that they return to their position of rest after being p 11. Slow case c.b. and check burn-off on the moving contact
- Before mounting fixed contacts, coat top flanges with gr 13. Slow open c.b. and replace fixed contacts
- Remove pressure valves and oil level gauges - clean and
- Replace top caps and refill oil
- Oil test before filtering/changing
 - dielectric strength kV for 1 min
 - acidity mg koh/gm
- Oil test after filtering/changing
 - dielectric strength kV for 1 min
 - acidity mg koh/gm
- Check for oil leaks. Repair if necessary
- Clean and check porcelain insulators for cracks, chips,

- Remove inspection covers and check for loose, worn or rust- repair and replace as necessary and then lubricate
- Check that all circlips and retaining pins, etc are secure

- Check for faulty or burnt contactors. Replace if necessary
- Lubricate/grease the chain drive and gearing
- Check that the heater works
- Check operation of motorized spring charging mechanism
- Close/trip c.b. via local control switch
- Close and trip c.b. via manual tripping mechanism
- Close/trip c.b. via remote control switches
- Close/trip c.b. via supervisory when possible
- Confirm with control that all alarms have been received
- Check that on/off indicator and counter mechanism is working counter reading
- Check that the c.b. is properly labeled
- Remove scaffolding and roping
- Return to service
- Circuit breaker poles:
 - Check the oil level of poles
 - Check the dielectric rigidity of breaking oil and the insulating oil of the poles
 - Change the upper cover gaskets (fill in according to the type of circuit breaker)
 - Check and grease the contact jaws (for withdrawable circuit breaker)
 - Change the oil indicator and drain cocks of the poles
 - Clean and grease the poles connection linkage
 - Measure the race stroke and penetration of the moving contacts rods
 - Measure the contact resistance of each pole
- Spring mechanism
 - Clean and lubricate (if necessary) each operating mechanism
 - Measure the flywheel slip of the operating mechanism
- Hydraulic mechanism
 - Record the pump starting operations
 - Check the level of oil tanks
 - Check the oil pressure switch operating thresholds

7.7. Circuit breaker performance tests

The scope of work highlighted below, shall be used for all the circuit breaker voltage levels.

- Conduct routine circuit-breaker functional tests in accordance with manufacturer's specifications.
- Test the operation of the control circuitry, (tripping, closing, alarms, interlocks, closing coils, shunt-release, low voltage release, over current release and charging motor circuit.)
- Test and record the following operating characteristics of the CB:
 - ❖ closing time;
 - ❖ opening time;
 - ❖ time spread between units of one pole of the CB;
 - ❖ time spread between poles of the CB;
 - ❖ recharging time;

- ❖ duration of opening and closing command pulse;
- ❖ resistance of the main circuit;
- ❖ Trip and closing coil current of the CB.
- ❖ Insulation resistance
- Check oil consumption after operation cycles
- Check the setting of oil thresholds
- Check alarms and locking system
- Verify energy of operating mechanism
- Record all results on test report
- The tested CB shall be identified by sticker/label stating “Tested, Date, Company and name of person” recorded.

7.8. SPARES

- The service provider shall buy initial stock of spare parts based on a recommendation from the results of the **Condition Assessment as per clause 7.5** to maintain the spares parts inventory
- The offer for the spares shall be added to the contract on completion of the conditional assessment.
- The service provider shall create a database identifying all spare parts with their current location, status, quantity and historical movement.
- The database shall be maintained by the service provider to accurately reflect the current status of all spare parts
- Where items are beyond repair or uneconomical to repair then the service provider shall manage the replacement of items, subject to cost approval from eThekweni electricity's HV Substations Manager or his duly authorised representative, provided such replacements can be covered under the scope of this contract.
- Any deviation from the agreed level of spares shall be discussed and agreed with from eThekweni electricity's HV Substations Manager prior to such action being taken.
- Three times per year the service provider shall undertake a stock take and provide a spares inventory report to eThekweni electricity's HV Substations Manager or his duly authorised representative

7.9. The service provider shall comply with the following arrangements and procedures:

- The key staff will have a ORHVS certificate and will keep it in tack for the duration of contract
- The Key stall shall be in possession of eThekweni electricity's safety rules course certificate or will be deemed to attend and pass the training of the mentioned coursed
- Key staff that will work on the CB must be approved by the OEM.
- Control centre will de energize (switch off) the circuit breaker that is identified for service.
- Control centre will test to confirm that equipment is dead.
- Earth of equipment. (where applicable).
- Barricade isolate area. No one will work outside this area.
- Submit a written isolation permit.

- The service provider will do a safety test to ensure the equipment that he is working on is safe to do so. (mechanical and electrical).
- Received and sign permit by all. (every one that is working on that equipment will sign the permit).
- An application for a Work Permit, together with the proposed work schedule, shall be submitted to the service provider at least three full working days before starting work.
- Maintenance tasks performed shall be as stipulated on the job cards

7.10. The service provider shall comply with the following requirements: during maintenance phase.

- Comprehensive functional test is required on CB before work/service on that breaker can begin. (footprint)
- Comply with all the procedures for working in substations and outdoor switchyards. (sign lock out permit and work in perimeter that is barricade)
- Comply with procedures for the handling of oil.
- Comply with procedures for handling of SF6 gas.
- Use the correct test instrument/equipment design for specific test(s), equipment used shall be stated in **Annexure 10.3**
- Before any maintenance work is carried out, the SERVICE PROVIDER shall make sure that the CB is de-energized and isolated from the electrical supply.
- Repair requirements on any part of the system shall be reported to the eThekwini electricity's HV Substations clerk of works. Follow up job card shall be generated.
- Job cards shall be signed off by the service provider after completion of the task and will be accepted as hand over certificate.
- eThekwini electricity's HV Substations clerk of works shall inspect and approve the maintenance work together with the service provider supervisor before Job cards are signed off. (will accept as hand over certificate).
- eThekwini electricity's HV Substations clerk of works shall reserve the right to witness testing.

7.11. MANAGEMENT AND REPORTING

- The service provider shall issue progress reports for each work done to the eThekwini electricity's HV Substations Manager or his duly authorised representative, at the following intervals from the time an instruction to commence work at Site:

1	After 2 hours then at intervals of 2 hours
2	After 24 hours then at intervals of 24 working hours
3	After 4 Working Days then at intervals of 48 working hours

7.12. BIDDER'S (COMPANY) EXPERIENCE

It is a minimum requirement that the Tenderer shall have completed at least **Five** projects with respect to Maintenance of High and Medium Voltage Circuit Breakers within the past **10 years**. Failure of the Tenderer to meet this minimum requirement shall result in the disqualification of the tender.

7.13. PERSONNEL (STAFFING REQUIREMENTS AND COMPETENCY)

The Tenderer shall submit details of the qualifications and experience of each personnel to be associated with this contract in **Schedule: Experience of Key Staff**. In addition, Tenderers shall submit documentary proof of such experience in the form of Curriculum Vitae, and contactable references by previous or current employer. Only Specialists and Electricians employed by the company at the time of evaluation will be considered.

7.13.1. 275 and 132 kV SF6 Circuit Breaker Specialist

The person(s) shall hold at least a National Higher Diploma in Electrical/Mechanical Engineering qualification and at least **eight years** SF6 Breaker with Spring and/or Hydraulic mechanisms; installation, maintenance, repair and condition assessment experience. Furthermore, the Specialist must be proficient in High Voltage SF6 Circuit breaker testing and analysis and make recommendations based on the results.

7.13.2. 132 kV Oil Circuit Breaker Specialist

The person(s) shall hold at least a National Higher Diploma in Electrical/Mechanical Engineering qualification and at least **eight years** Oil Breaker installation, maintenance, repair and condition assessment experience. Furthermore, the Specialist must be proficient in High Voltage oil Circuit breaker testing and analysis and make recommendations based on the results.

7.13.3. 275 and 132 kV SF6 Circuit breaker Electrician

This person shall be a qualified Electrician with at least a N4 electrical a Trade Test Certificate and with at least **five years** of experience in the maintenance and repairs of 132 and 275 kV SF6 Circuit breaker with Spring and/or Hydraulic mechanisms.

7.13.4. 132 kV Oil Circuit breaker Electrician

This person shall be a qualified Electrician with at least a N4 electrical a Trade Test Certificate and with at least **five years** of experience in the maintenance and repairs of 132 kV Oil Circuit Breakers.

7.13.5. The same person can be recommended as SF6, Oil and Vacuum Circuit breaker if the qualifications and practical experience meets the minimum requirements of all fields.

7.13.6. The Contractor shall allocate two dedicated comprehensive teams for the purposes of this contract. If more than one dedicated team is provided, the Contractor shall state the number of teams and complete the respective **Experience of Key Staff** returnable schedules for each team member. The minimum staff compliment per main team shall be as follows:

- a) 1 Breaker Electrician
- b) 2 Semi-Skilled Workers
- c) 1 Breaker Specialist

Contractors shall communicate instances where teams are to include additional personnel such as Sub-Contractors for CPG requirements. This shall be communicated to the Senior Manager: HV Substations or his duly authorised representative for approval.

7.13.7. The sub-contractors for the CPG should consist of at least 1 electrician and 2 Semi-Skilled Workers in a team, that will be working together with the main contractor team. **30%** of the total contract value should be dedicated to the CPG sub-contractors; by means of:

- skills training and development (**formal/informal training**)
- Payment for the work performed during the contact period.

7.13.8. It is a requirement that all members of the allocated team/s for the purposes of this contract are locally based **within the eThekweni region**.

7.13.9. The progress meetings shall cover, but not limited to, the following topics:

- a) Proposed project time lines;
- b) Progress reports on projects;
- c) Challenges faced and recommended actions; and
- d) Continuous amendment of the technical specification for future contracts.

7.13.10. Professional Responsibility

Although the work may be scrutinised by qualified personnel of eThekweni Electricity, this will in no way relieve the Contractor of its professional responsibility for the proper and prompt execution of the duties.

7.13.11. Responsibility on Site

No staff of the Contractor shall be allowed to enter eThekweni Electricity's substations unless they are in direct control of a Specifically Trained Person. This Specifically Trained Person shall be a person who is employed by the Contractor and who has passed eThekweni Electricity Safety Rules Course and has been assessed by the Senior Manager: HV Substations.

7.13.12. Construction Industry Development Board (CIDB) Grading

It is a requirement that only those Tenderers who are registered with the CIDB at the time of tender closing, in a Contractor grading designation equal to or higher than **3EP** are eligible to submit tenders for the maintenance of transformers. Failure of the Tenderer to meet this requirement shall result in the disqualification of the tender. The Tenderer shall submit proof of his/her CIDB registration and grading as well as the respective CRS number.

7.13.13. Response Time

The Contractor shall provide a maximum response times of 2 hours for emergency work and 24 hours for other work that may arise at any time.

7.13.14. Method Statements

The Contractor shall be required to produce method statements on all work to be conducted for the purposes of this Contract. The method statement shall highlight detailed correct working procedures and safety measures for each and every task listed as per the

statement. The method statement shall be submitted to the Senior Manager: HV Substations or his duly authorised representative for approval prior to the commencement of work.

7.13.15. Execution plan/ methodology

Bidders shall submit a comprehensive scope execution plan in which as a minimum they detail the following:

- a) Maintenance Procedure on different Medium and High Voltage level Circuit breakers
- b) Baseline schedule;
- c) Project risks and control measures;
- d) Skills transfer
