 - The Bidder has satisfactorily completed at least two contracts for the supply of any goods for Lot 1 and similar goods for Lot 2 in the preceding three years (2022, 2023 and 2024) of each contract: Lot1, Household Start-up: not less than USD 197,000.00; Lot2, Solar Light: not less than USD 101,500.00 and Total Lot1 and Lot2: not less than USD 298,000.00.
 - The Bidder has completed contracts of any goods in the preceding two years (2023 and 2024) in the total cumulative amount equal to: Lot1, Household Start-up: not less than USD 788,000.00; Lot2, Solar Light: not less than USD 406,500.00 and Total Lot1 and Lot2: not less than USD 1,194,000.00.
 - The Manufacturer of the offered Solar Light, if a different entity from the Bidder, has experience of at least 3 years in the manufacturing of similar goods.
 - The Bidder has availability of liquid assets through either:
 - a. access to a line of credit or cash in bank account of an amount at least: Lot1, Household Start-up: not less than USD 197,000.00; Lot2, Solar Light: not less than USD 101,500.00 and Total Lot1 and Lot2: not less than USD 298,000.00.
 - b. credit terms with vendors specifically for the goods to be supplied under the contract, and valid for at least 6 months after the deadline date for submission of bids specified in ITB Clause 21.
