## SCHEDULE V LIST OF PROPOSED SUB-CONTRACTORS

Bidders shall list all the sub-contractors who they intend to employ during execution of the works under this contract and indicate whether ownership of the sub-contractor is Zimbabwean or foreign (evidenced by the company's directorship and registration documents). All sub-contractors to be employed for the project should be Zimbabwean owned except for specialized services or material not available in Zimbabwe. The Bidders must prove beyond doubt that the services for foreign Sub-Contractors are not available in Zimbabwe.

An indication of employment of a foreign sub-contractor by a bidder shall be accompanied with adequate justification to the satisfaction of the Employer. Acceptable justification shall be absence of such service provider or material supplier on the local market. Any indication of the intention to import a sub-contractor without acceptable justification will result in disqualification of the tender.

Regardless of the Bidder's list of proposed sub-contractors, sub-contractors will not be allowed on the Contract without the written permission of the Engineer. The Engineer may withdraw his approval if in his opinion the performance of the Sub-contractor is unsatisfactory.

#### References

The definitions used in the Public Procurement and Disposal of Public Assets Act [Chapter22:23] ("the Act"), the Public Procurement and Disposal of Public Assets (General) Regulations (Statutory Instrument No. 5 of 2018) ("the Regulations") and the General Conditions of Contract for the Procurement of Non-Consultancy Services apply to this Standard Bidding Document. The Act and the Regulations govern the submission of Bids and should be read by all Bidders.

## **Preparation of Bids**

The Bidders are advised to carefully read the complete Bidding Document, as well as the General Conditions of Contract which are available on the Authority's website, before preparing your Bid. The standard forms in this document may be retyped for completion but the Bidder is responsible for their accurate reproduction. All pages of the Bid must be clearly marked with the Tender Number above.

In preparing their bid, bidders are encouraged to utilize local resources (personnel, plant, and materials) as much as is practicable.

Bids shall include a Table of Contents after the cover page and plastic page dividers should be used to separate different sections of the bid document for ease of finding documents.

#### Number of bids allowed

No Bidder may submit more than one Bid, either individually or as a joint venture partner in another Bid, except as a subcontractor. A conflict of interest will be deemed to arise if Bids are received from more than one Bidder owned, directly or indirectly, by the same person.

### INSTRUCTIONS TO TENDERERS

#### 1.0. SCOPE AND DESCRIPTION OF THE WORKS.

### a) Preliminary and Temporary Works

Preliminary and temporary works will include the erection and removal of temporary housing and offices for access and transport of materials to enable construction of the permanent works.

## b) Proposed Works.

The proposed works covered by this Tender document will involve.

- 1. Mobilization
- 2. Service of lowering system
- 3. Coating of pipes with Epoxy
- 4. To install 900mm butterfly valves
- 5. Procure and service of hydraulic controls for both sleeve valves
- 6. Service sleeve valves
- 7. Repair lighting system
- 8. Demobilization

### c) Miscellaneous

This shall include all other work described in this specification or ordered by the Engineer during the course of the contract.

#### d) Material Supplies

The Contractor shall satisfy himself of the proximity of the specified materials to the site of the works and fully allow for their transportation at the specified rates where relevant.

- b. One of the partners shall be nominated as being in charge; and this authorization shall be evidenced by submitting a power of attorney signed by legally authorized signatories of all the partners,
- c. The partner in charge shall be authorized to incur liabilities and receive instructions for and on behalf of any and all partners of the joint venture and

- the entire execution of the Contract including payment shall be done exclusively with the partner in charge,
- d. #### 19.0. BRIBERY AND COLLUSION

Any effort by the Tenderer to influence the Employer in the process of examination, clarification, evaluation, and comparison of Tenders and decisions concerning recommendations of award of Contract shall result in the rejection of the Tenderer's Tender.

# 20.0. WITHDRAWAL, AMENDMENT OR MODIFICATION OF BIDS

A Bidder may withdraw, substitute, or modify its Bid after it has been submitted online through the EGP system.

- **20.1.** The Tenderer may modify and / or withdraw his Tender after Tender submission, provided that the modification or notice of withdrawal is received in writing by ZINWA prior to the prescribed deadline for submission of Tenders.

Unsuccessful Bidders will receive the Notification of Contract Award and, if they consider they have suffered prejudice from the process, they may, within 14 days of receiving this Notification, submit to the

## 30.0. NOTIFICATION OF AWARD

- **30.1.** Prior to the expiration of the period of Tender Validity prescribed by the Employer, the Employer shall direct which Tender is to be accepted and notify promptly in writing the successful Tenderer, and
- **30.2.** The notification of Award will constitute the formation of the Contract. The unsuccessful Tenderers shall be advised in writing by the Employer of the name of the successful Tenderer and the amount of the Bid Price accepted.

## 31.0. SIGNING OF CONTRACT AGREEMENT

The form of Performance Security provided in Schedule VII of the bidding documents shall be used.
- **33.2.** Failure by the successful Tenderer to comply with the requirements of Clause 36.1 shall constitute sufficient grounds for the annulment of the Award and forfeiture of the Tender Security.

#### 34.0. CORRUPT PRACTICES

The Government of Zimbabwe requires that Procuring Entities, as well as Bidders and Contractors, observe the highest standard of ethics during the procurement and execution of contracts. In pursuit of this policy:

#### SPECIFICATION AND SPECIAL CONDITIONS OF CONTRACT

#### **PART A: GENERAL**

#### **GENERAL CONDITIONS**

The General Conditions of Contract which form part of these contract documents shall be the First Edition prepared in 1999 by the *Federation Internationals des Ingenieurs Conseils* (FIDIC) entitled Conditions of Contract for Construction with such alterations and additions as are affected under the following Clauses. Clauses are numbered here applicable, in accordance with the clause numbers in the FIDIC Document.

The **FIDIC** Conditions of Contract for Construction is not issued with these tender documents but may be obtained from the parent body. That is, the Employer will NOT supply copies of these conditions to the Contractor.

## A2 DEFINITIONS AND INTERPRETATIONS

The following definitions in the General Conditions of Contract Clause 1.1 shall hold for the purpose of this Contract.

1.1 (a) (i) "Employer" means the ZIMBABWE NATIONAL WATER AUTHORITY

## A3 AMENDMENTS TO GENERAL CONDITIONS OF CONTRACT

The General Conditions of Contract are amended as follows:

## (a) Clause 1.8: Custody and Supply of Drawings and Documents

The following sub-clauses to be added:

- **1.8** (a) No drawings or documents or any information contained therein, forming part of this Contract shall be used for any purpose other than this Contract. Upon settlement of the Final Account for this Contract, the Contractor shall return all drawings and Specifications to the Engineer.
- **1.8 (b)** Figured dimensions shown on drawings take precedence over scaled measurements and if due to the absence of figured dimensions, it is necessary to obtain dimensions from scaled measurement, the Contractor shall verify such dimensions with the Engineer.

## (b) Clause 8.3 - Programme

Replace the words "within 28 days after receiving the notice under Sub-Clause 8.1 [Commencement of Works]" with "Within fourteen days after signing of the Contract".

The Contractor shall revise the Programme at monthly intervals with a projected schedule of monthly cashflows (to the Contractor).

The Contractor shall not commence any separate operation without the consent of the Engineer, to whom the Contractor shall have given full and complete notice of the operation sufficiently in advance of its proposed commencement so as to enable the Engineer to make such arrangements as he may deem necessary for measurement, inspection, or any other purpose.

# (c) Clause 6.8 - Contractor's Superintendence

Add the following;

'The Contractor's approved representative shall be fluent in the English Language.

The Contractor shall ensure that an adequate number of his supervisory staff and technical assistants shall be able to communicate in English and a reasonable proportion of foremen shall have a working knowledge of English and local languages to ensure the proper transmission of information and instruction.'

## (d) Clause 4.7 – Setting Out

Add the following;

'The Contractor shall give not less than twenty-four (24) hours notice to the Engineer of his intention to set out a section of the works or give levels, so that arrangements can be made for checking or issuing instructions'.

# (e) Clause 18.2- Insurance of Works and Contractor's Equipment

In line 1, add "Prior to the commencement of the Works,"

At the end of the Clause add "It shall be the responsibility of the Contractor to notify the insurance company of any change in the nature and extent of the Works and to ensure the validity of the insurance cover during the duration of the Contract".

## (f) Clause 18.4 – Accident or Injury to Workmen

Add the following

'The Contractor shall also pay the stipulated dues in respect of all his workmen to the Workmen's Compensation Fund of Zimbabwe and to the National Social Security Authority (NSSA) in accordance with Government regulations and shall ensure that all subcontractors engaged on works under this Contract do likewise".

# (g) Clause 4.14 – Interference with Traffic and Adjoining Properties

Add the following sub-Clause;

(c) Compliance with State Traffic Laws.

Nothing herein before contained shall exempt the Contractor or any of his sub-contractors from complying with State Laws and or Municipal By-Laws regulating traffic on roads and bridges.

## (h) Clause 6.1 – Engagement of Staff and Labour

Add the following;

### **6.1** (b) Importation of Labour

The importation of labour and personnel shall be subject to the Statutes, Ordinances, Laws, Regulations and By-Laws of the Republic of Zimbabwe in force from time to time and no personnel or labour shall be imported by the Contractor without first obtaining the necessary permission of the Employer and Permits from the appropriate Authorities.

## (j) Clause 14.8- Delayed Payment

Replace paragraph 2 with,

"Financing charges shall be calculated at the prevailing minimum commercial bank rate for overdrafts plus 2% per annum," in place of "stated in the Appendix to Tender".

Add "The Contractor shall provide proof of borrowing from the bank to attract an interest rate of the prevailing minimum commercial bank rate for overdrafts plus 2% per annum, else the Employer shall pay an interest rate afforded to the Employer by the funding institution plus 2%. Interests charged shall not be compounded."

#### (k) (i) Date of Tender

For the purpose of this Clause the term "date of Tender" shall mean the date at which the Contract was awarded.

## (ii) Special Provisions for Materials

- (a) Before placing orders for any material subject to price variation in terms of this Clause at prices other than those quoted in Schedule VIII, the Contractor shall advise the Engineer in writing of such intended purchase and state the value of any trade or other discounts applicable. The Contractor shall acquire no material costing more than 10% above the price given for it in the said Annexure for the works without prior written approval of the Engineer.
- (b) The Engineer shall have the right to instruct the Contractor to buy any material subject to this Clause to best advantage. The Employer shall have the right to purchase such material himself for re-sale to the Contractor.

## (iii) Consumables

The Contract price shall not be subject to adjustment in respect of variations in prices of consumable items such as electrical power, lubricants, tyres, drill bits, spare parts etc.

## A4 AMENDMENTS BY TENDERER

Should the Tenderer desire to make any departures from, or modifications to, the General Conditions of Contract, Specification, Bill of Quantities or Drawings, or to qualify his Tender in any way, he shall set out his proposals clearly in a covering letter attached to his Tender or in Annexure 'A' to the Form of Tender, failing which the Tender will be deemed to be unqualified.

## A5 QUALIFICATION AND EXPERIENCE OF TENDERER

Tenderers are required to submit, with their offer, a statement of previous steel modification experience and lists of staff and labour. They shall also provide curricula vitae of key staff members who will be employed on the works, demonstrating their ability to execute works of a demanding technical standard within a limited contract period. An indication must be given of the period that such staff and labour will be on site.

If the Tenderer finds any discrepancies or difficulties in carrying out any part of the works as specified, such discrepancies and/or difficulties shall be clearly explained.

#### A6 SURETIES

Referring to Clause 4.2 of the General Conditions of Contract, Tenderer shall state in their Tender the proposed sureties or guarantors and provide proof that they will provide a Bond/Deed of Suretyship.

#### A7 INSURANCES

Any insurance taken out by the Tenderer in accordance with Clause 18.1 to 18.4 of the General Conditions of Contract or for any other reason in connection with the Contract shall be effected through a firm registered in Zimbabwe.

## A8 PROVISION OF SERVICES TO THE ENGINEER

It is to be noted that the Contractor is responsible for the rehabilitation of the Works as described in the Specification and shown on the Drawings or as may otherwise be directed and is also entirely responsible for the provision of temporary housing and all services to his own staff and employees.

The Contractor shall be required to provide housing and offices, for the use of the Employer, the Engineer or their staff or employees. If specifically requested to do so at any time, the provision of such services shall be made under the specific Items and Provisional Sums provided for this purpose in the Bill of Quantities. The Contractor shall be entitled to a mark-up on Prime Cost items under Provisional Sums only, at the percentage rate tendered.

The contractor is specifically required to provide the following which shall be specified by the Engineer at the time of purchase: -

a) Any other capital items required by the Engineer for the execution of the Contract.

## A9 QUALITY CONTROL SITE LABORATORY

All work shall undergo quality control by the engineer's representative. Work which fails the quality control shall be re-done

Notwithstanding the above, the Contractor shall at all times be free to carry out, at his own expense, any tests that he may wish as an aid to control his operations. In the event of any lack of agreement on test results, those results from the Engineer's site laboratory shall be taken as ruling.

# A10 ACCESS TO LAND REQUIRED FOR THE WORK

Not applicable on this contract.

## A13 PROVISIONAL QUANTITIES

All quantities shown in the Bill of Quantities have been calculated in good faith and to the best information available.

Items marked "Provisional Sum" are not subject to alteration or deletion by the Contractor in his tender submission.

#### A14 MEASUREMENT

For the purpose of measuring such permanent work as is to be measured by record Drawings the Engineer's Representative shall prepare record Drawings from time to time of work and the Contractor as and when called upon to do so in writing shall, within seven (7) days, attend to examine and agree to such record Drawings with the Engineer's Representative and shall sign the record Drawings when so agreed. If the Contractor does not attend to examine and agree any such record Drawings, they shall be taken as correct. If, after examination of such record Drawings, the Contractor does not agree with them and does not sign as agreed, they shall nevertheless be taken as correct unless the Contractor, shall within seven (7) days of such examination, lodge with the Engineer, notice in writing of the respect in which such record Drawings are claimed by him to be incorrect.

#### A15 ADVANCE PAYMENT

Payment will be after completion of the works (No advance payment)

#### A16 PROGRAMME OF WORKS

The Contractor is required to provide a programme of Works and a comprehensive Method Statement showing that they are able to achieve the target date for commencing repairs and the contract completion date as stated in Clause B15 of this Specification. This requirement is additional to the routine programme for execution of the Works as described in the Conditions of Contract.

It is a prime condition of this Contract that the target dates and completion date is achieved, regardless of all other factors such as date of commencement and altered conditions or quantities of work.

#### A17 STAFF AND PERSONNEL

The Contractor is required to list, in the Contract Document, the staff and personnel who will be employed on the contract. If it is the intention to employ expatriate personnel, it will be the Contractor's sole responsibility to obtain the necessary Residence Permits and Work Permits. The Contractor is required to employ locals from areas surrounding the Works as his temporary and permanent labour force. The Contractor shall also ensure that his authorized representative and an adequate number of the Contractor's supervisory staff shall be able to speak English.

## A18 NOTICE OF WORK AND APPROVAL TO PROCEED

At least ten (10) days before the start of any part of the Works that will result in a disruption of irrigation water supply, the Contractor shall notify the Engineer's Representative in writing of his intentions.

The Contractor shall submit requests in writing to the Engineer for approval to commence any and all operations involving the installation of permanent works.

## A19 RETURNS TO BE SUBMITTED BY CONTRACTOR

The Contractor shall submit monthly returns in duplicate to the Engineer, showing the Site Agent, number of artisans and labourers employed upon the works, listing all plant on site together with daily hours worked, idle or broken down, and indicating whether each item of plant is owned by the Contractor or hired.

### A20 SITE VISITS

Tenderers shall visit the site and acquaint themselves with the difficulties they will have to overcome, etc and all Tenderers shall complete the "Certificate of site visit".

Tenderers are at liberty to visit the site at their convenience, but an official site visit will be arranged. Instructions regarding the date, time and meeting place for the official site meeting are given in the instruction to Tenderers that accompany these documents. The Engineer and members of his staff will not accompany Tenderers to site at any other time.

## PART B: SITE DATA AND DESCRIPTION OF THE WORKS

#### B1 SCOPE AND DESCRIPTION OF THE WORKS

This Contract comprises the following Works:

a) Preliminary and Temporary Works

Preliminary and temporary works will include the erection and removal of temporary housing and offices for access and transport of materials to enable construction of the permanent works.

Proposed Works.

The proposed works covered by this Tender document will involve.

- 1. Mobilization
- 2. Service of lowering system
- 3. Coating of pipes with Epoxy
- 4. To install 900mm butterfly valves
- 5. Procure and service of hydraulic controls for both sleeve valves
- 6. Service sleeve valves
- 7. Repair lighting system
- 8. Demobilization

## b) Miscellaneous

This shall include all other work described in this Specification or shown on the Drawings or ordered by the Engineer during the course of the Contract.

#### B2 LOCATION OF SITE AND ACCESS

Mazvikadei Dam is on Mukwadzi River, 25km north of Banket at 17 ° 13'14"S 30 ° 23'30" E.

## B5 ACCOMMODATION AND CONTRACTOR'S AREAS

The general area that will be available to the Contractor for his housing, workshops, offices, stores and plant yards shall be sited to the approval of the Engineer's Representative in consultation with other interested parties.

Labour shall be housed in units with no more than two (2) bachelors or one family to a three (3) metre square room. In bachelor accommodation, each individual shall be provided with at least four point five (4.5) square metres of floor area and ten (10) cubic metres of air space, and the rooms shall be cross ventilated. Housing units shall be built of durable material and be of an acceptable standard appropriate to the duration of the Contract.

Adequate cooking shelters shall be provided. These shall be roofed structures, three sides of which shall be protected to a height of at least one (1) metre above ground level.

The Contractor shall be responsible for the control of all his labour housing in the compound or elsewhere, and shall follow the instructions of the local authority in all relevant matters.

On completion of the Contract, all labour housing and associated structures shall be demolished and the materials removed or disposed of to the satisfaction of the Engineer. All costs involved in the construction and maintenance of staff and labour housing shall be allowed for under the appropriate Lump Sum tendered in the Bill of Quantities.

#### B8 PROTECTIVE CLOTHING AND SAFETY

The Contractor shall provide all his workmen with adequate protective clothing appropriate to the type of work on which each individual is occupied, and in accordance with the industrial regulations.

Safety equipment including nets or harnesses shall be provided where necessary. The Contractor shall provide and maintain on site such first-aid and life saving apparatus as may be appropriate and as may be required under any Government regulations. In addition, an adequate number of persons permanently on the site shall be instructed in their use. Arrangements for obtaining immediate first-aid, if and when required, shall be made known to all persons on site.

It shall be the sole responsibility of the Contractor to prevent access to the site by unauthorized persons and to ensure safety to public and private property and individuals.

## **B9** WATER FOR DOMESTIC PURPOSES

The Contractor must provide and install at his own cost all necessary equipment to ensure an adequate supply of potable water to his workforce, both at housing areas and at the jobsite. The contractor will upgrade and rehabilitate the existing ZINWA potable water supply plant at the dam site.

#### **B11 TELEPHONE AND ELECTRIC POWER**

The Contractor must make his own arrangements and pay for the cost of installing telephones or wireless links and for the provision of electric power for both his domestic and constructional use.

## **B14 PROGRAMME AND COMPLETION DATES**

The Contractor shall draw up a schedule showing the approximate nature and extent of the plant and labour, including staff, to be used on the Works. The Contractor shall also draw up a programme showing the general scheme of operations proposed. The schedule of plant and labour and the programme shall be attached to the Tender. From time to time this programme will be reviewed and if required by the Engineer, the Contractor shall draw up a revised or amended programme in accordance with the actual conditions prevailing at the time.

Preference will be given to those Bidders offering the equipment best suited for the task and demonstrating adequate reserves, so that in the event of the Contractor's programme falling behind schedule, an accelerated programme may be instituted.

#### **B15 DRAWINGS**

The Engineer shall issue detailed drawings to the Contractor as construction proceeds and sufficiently in advance of work on any section to allow the necessary planning and preparation, and in accordance with the Programme of Works as revised from time to time.

The following Drawings form part of this Specification and Contract

## PART E: PIPELAYING

## E1 SUPPLY OF BUILT-IN PARTS

Built-in parts to be supplied as part of billed items for supply and installation shall be selected from quotations obtained by the Contractor from commercial sources, or by the Engineer. In the case of supply from commercial sources, the Contractor shall obtain at least three quotations from different suppliers or manufacturers and the Contractor shall base his billed price on the least expensive item that satisfy these specifications and those stated in the "Specifications for EMERGENCY REHABILITATION OF MAZVIKADEI DAM OUTLET WORKS" document.

### E2 INSTALLATION OF PIPEWORK

All pipework shall be laid accurately to the lines and grades shown on the Drawings, installation manuals provided by the supplier or Engineer and or as described by the Engineer. Where necessary pipework shall be supported on concrete plinths or steel chairs and only steel wedges or spacers used shall be allowed to remain within the concrete or permanent works.

The tightening of bolts on couplings and flanges shall be carried out using appropriate tools to ensure sufficient torque is applied without over-stressing.

The Contractor shall take every precaution to ensure that all protective coatings are not damaged and if damage does occur, shall repair it at his own expense and under the supervision of the Engineer's Representative.

Items are included in the Bill of Quantities for the installation of all pipework and valves, and shall include unloading at site, handling, moving, aligning and installation of the pipes into their final position and water testing before concreting in.

#### E3 INSTALLATION OF VALVES

Installation instructions for the valves shall be supplied by the valve manufacturers and the Engineer and the Contractor shall adhere strictly to these instructions at all times. The Contractors will be responsible for commissioning the valves and whole pipework system and testing the system in accordance with Specifications or Engineer's instructions.

Payment for this work shall be included in the relevant items in the Bill of Quantities for the installation of steel pipework and valves in the works.

## E4 INSTALLATION OF MISCELLANEOUS STEELWORK

The Contractor shall install all miscellaneous steelwork and other metal work such as hand-railing, flooring, ladders, gantries, small diameter pipework, etc. to details shown on the Drawings or as directed by the Engineer's Representative. All steelwork shall be accurately positioned and maintained in position during concreting operations.

Before delivery to site the steelwork may be covered with primer coats of paint. The Contractor shall take every precaution to prevent damage to the paint. Final coats will be applied as detailed under Clause G7 below.

Payment for work done under this Clause shall at be at the rate tendered in the Bill of Quantities.

#### E5 STEEL PIPEWORK

All pipe systems for whatever service shall be measured net as laid and jointed and the rates shall include for all necessary cutting and waste of pipes and short lengths required to suit fittings, etc and for all labour and materials required in the laying, jointing and testing where specified, of the various types of pipes and fittings in accordance with this Specification.

Payment for work done under this Clause shall be paid for under the appropriate items in the Bill of Quantities

#### E6 INSTALLATION OF OTHER BUILT-IN PARTS

Not Applicable.

## E7 PAINTWORK

All final painting required for pipes and other steel work shall be according to Specifications.

# PART F: SPECIAL SPECIFICATIONS FOR THE REHABILITATION OF THE HYDRO-MECHANICALS OF MAZVIKADEI DAM

#### 1. STEEL PIPE WELDING

All steel pipe welding **MUST BE SUBMERGED ARC WELDING** and must conform to API Standard 650.

Bidders must indicate their capability to carry out this type of welding for all the pipework for the project.

#### 2. RUBBER JOINT GASKETS

Rubber jointing rings used in any pipework shall be of the type and quality recommended by the pipe manufacturers and typical samples shall be submitted to the Engineer prior to use for approval. Generally, they shall comply with ISO 4633:2015 (Rubber seals).z

#### 3. BUTTERFLY VALVES

Butterfly valves shall be in accordance with B.S. 1092-1-2007 (Flanges and their joints), API 6D (Specification for pipeline valves), API 598 (Valve inspection and testing), API 600 (Steel gate valves, flanged and buttwelding ends) and API 650 (Welded Tanks for Oil Storage).

#### 4. STOP VALVES

Stop Valves, 50 mm diameter and under shall be screw-down type manufactured in accordance with B.S. 1092-1-2007 (Flanges and their joints), API 6D (Specification for pipeline valves), API 598 (Valve inspection and testing), API 600 (Steel gate valves, flanged and buttwelding ends) and API 650 (Welded Tanks for Oil Storage). Ends to be female screwed with hexagonal shoulders. Closing shall be clockwise.

## 5. GATE VALVES

Gate Valves and Sluice Valves shall comply with B.S. 1092-1-2007 (Flanges and their joints), API 6D (Specification for pipeline valves), API 598 (Valve inspection and testing), API 600 (Steel gate valves, flanged and buttwelding ends) and API 650 (Welded Tanks for Oil Storage) and shall be of the key opening type, complete with cast iron cap. Closing shall be clockwise.

For all other pipework, double flanged valves shall be used.

Large diameter valves shall be PN 16 or as otherwise shown on the drawings.

### 6. NON-RETURN VALVES

Non-return valves shall be of the reflux recoil type or similar approved in accordance with B.S. 1092-1-2007 (Flanges and their joints), API 6D (Specification for pipeline

valves), API 598 (Valve inspection and testing), API 600 (Steel gate valves, flanged and buttwelding ends) and API 650 (Welded Tanks for Oil Storage).

#### 7. STEEL PIPE MATERIAL SELECTION

This is the process of selecting the appropriate steel sheets for the fabrication of all the steel pipes and laterals for the pipeline and pump connections. The designed steel sheet composition requires steel materials of Grade GR50B, with a Tensile Strength of between 470-630MPa and a minimum Yield Strength of 355(min) and a Charpy Impact Test result of 27J@20°C according to BS4360 (Gr50B) (Alternatively SANS 1431-350WA). For compliance monitoring, the Contractor is to provide a mill certificate for all the materials. **All steel plates must be stamped and readily available for inspection** before, during and after fabrication and refer to EN10204 specification on inspection documents.

# 8. STEELWORK AND PIPE WELDING INSPECTIONS

The purpose of this standard is to present methods for the production of high-quality welds through the use of qualified welders using approved welding procedures, materials and equipment. Its purpose is also to present inspection methods to ensure the proper analysis of welding quality through the use of qualified technicians and approved methods and equipment. It applies to both new construction and in-service welding according to API-1104 and API-650. The Contractor is to provide valid certificates for high pressure vessel coded welders and should be able to demonstrate the equipment capabilities on proto-types in the workshop. Welding inspection certificates must be produced at a frequency stated in the standard and test reports must be produced.

# 9. FLANGES AND THEIR JOINTS- CIRCULAR FLANGES FOR PIPE, VALVES, FITTINGS AND ACCESSORIES PN, DESIGNATED

BS1092-1:2007 specifies the flange types and their facings, dimensions, tolerances, threading, bolt sizes, flange jointing face finish, marking, materials, pressure/temperature ratings and approximate flange masses. (Alternatively EN1092-1, API-650). The contractor is to produce the manufacturers product certificate stating the test pressure results.

#### 10. PRESSURE TESTING FOR S355JR STEEL PIPES

BS EN806 specifies that all new water systems, both above ground and below ground shall be tested hydraulically prior to commissioning. To satisfy the recommendations given in BS EN806 fittings and pipework must be pressure tested at  $1.1 \times (1.5 \times \text{maximum design pressure})$  or  $1.65 \times \text{maximum operating pressure}$ . The Contractor is to produce pressure test certificate from the standard association of Zimbabwe (SAZ) or a recognised certification body. Strict adherence to the laid down pressure test procedures as specified in the standard specifications.

#### 11. PAINTWORK

The Contractor shall provide painting and coatings, complete and in place, in accordance with the approved plans and standard specifications. Except as otherwise indicated by the Engineer, the current editions of the following apply to the work of this section:

- A. ANDSI/AWWA C210 Liquid Epoxy Coating Systems for the Interior and Exterior of Steel Water Pipelines
- B. ANSI/AWWA C213 Fusion-Bonded Epoxy Coating for the for the Interior and Exterior of Steel Water Pipelines
- C. ANSI/AWWA C217 Cold-Applied Petrolatum Tape and Petroleum Wax Tape Coatings for Exterior of Special Sections, Connections, and Fittings for Buried Steel Water Pipelines.
- D. BS 5493 Code of Practice for Protective Coating of Iron and Steel against Corrosion

The following shall be submitted in compliance with the standard specifications:

- 1. Submit coating manufacturer's technical and material safety data sheets for the products to be applied. Data sheets shall sow the following information at a minimum, but shall show all data necessary to indicate conformance to specifications:
  - a. Percent solids by volume.
  - b. Minimum and maximum recommended dry-film thickness per coat for prime, intermediate, and finish coats.
  - c. Recommended surface preparation.
  - d. Recommended thinners.
  - e. Statement verifying that the specified prime coat is recommended by the manufacturer for use with the specified intermediate and finish coats.
  - f. Application instructions including recommended equipment and temperature limitations.
  - g. Curing requirements and instructions.
  - h. Colours (where applicable).

# 11.1. QUALITY ASSURANCE

All materials of a specified painting system, including primer, intermediate, and finish coats, shall be produced by the same manufacturer. Thinners, cleaners, driers and other additives shall be as recommended by the paint manufacturer for the particular coating system.

Deliver paints to site in the original unopened containers.

## **BILL OF QUANTITIES**

### PREAMBLE TO BILL OF QUANTITIES

#### 1. **GENERAL**

- a) Attention is drawn to the General Conditions of Contract, Form of Tender, Specification, Drawings, attached schedules and amendments thereto contained in this document. These documents are to be read in conjunction with the Bill of Quantities.
- b) Each item, including zero items, shall be priced with the exception of those items which already have provisional sums attached thereto, if the Tenderer omits to price any item, the cost of such items will be deemed to be spread over and included in the prices tendered for other items.
- c) The quantities in this Bill are provisional. The work as completed will be measured according to the provisions of the General Conditions of Contract and of the Specification.
- d) The rates and prices in the Bill of Quantities shall be deemed to cover all the Contractor's obligations under the contract and all matters and things necessary for the proper completion and maintenance of the works.
- e) Where alternative rates have been called for in the Bill of Quantities, the Engineer reserves the right to use any of the alternative materials or forms of construction.
- f) The Contractor must note that materials for the contract are to be ordered from the working drawings as checked where necessary from site measurements. They must not be ordered from either the Bill of Quantities or the Tender drawings without the written permission of the Engineer.
- g) Where the item in the Bill of Quantities is described as "Provisional" the rate entered against the item holds for any variation in the quantity provisionally billed.
- h) Contractors are encouraged to use materials produced or manufactured in Zimbabwe, providing that the price, quality and delivery of local material is satisfactory.
- j) The total amount under PRELIMINARY AND GENERAL items excluding provisional sums must not exceed ten percent (20%) of the total Contract Sum.
