- 10. To enhance equity, bidders will only be Awarded a Maximum of **Two (2)** Tenders, under this Tender Notice and the most advantageous to the employer.
- 11. Director (s) bidding under different companies for the same tender will be disqualified.
- 12. Errors in the pricing of the Bills of Quantities will not be corrected. Bidders with such errors will be disqualified.
- 13. All pages of the tender documents submitted by bidders shall be sequentially serialized including the cover page.
