# PART A – THE TENDER

## INTRODUCTION TO THE NRF

The National Research Foundation Act as amended, Act 19 of 2018, establishes the National Research Foundation ("NRF") as the juristic legal entity that will contract with the awarded bidder. Please visit the NRF website (<https://www.nrf.ac.za>) for more information.

## INTRODUCTION TO SARAO

The South African Radio Astronomy Observatory (SARAO) is the NRF's National Facility incorporating South Africa's radio astronomy instruments and programmes such as the MeerKAT and KAT-7 telescopes in the Karoo in the Northern Cape, the Hartebeesthoek Radio Astronomy Observatory (HartRAO) in Gauteng, the African Very Long Baseline Interferometry (AVN) programme in nine African countries as well as the associated human capital development and commercialisation endeavours. ## OBJECTIVE OF THE TENDER

The SARAO Receivers Team requires a 26 GHz Spectrum and Phase Noise analyser in order to fulfil its mandate of delivering cutting edge technology in the field of RF receivers for Radio Astronomy applications. This instrument will be used in the SARAO Receivers Laboratory. This Spectrum and Phase Noise analyser will replace an aging spectrum and phase noise analyser and also a noise figure meter which is no longer calibratable due to its age. The new equipment will enable new measurement capabilities in terms of phase noise and noise figure.

## SECTION A: SPECTRUM AND PHASE NOISE ANALYSER SPECIFICATIONS

### 1. Supplier Specification

The SARAO Receivers team requires a qualified and experienced supplier to deliver a Spectrum and Phase Noise Analyser capable of operating up to 26 GHz. The purchase also includes a noise source and an RF power meter. The spectrum and phase noise analyser, the noise source and the RF power meter should be supplied with its own rugged, foam-lined enclosure.

### 2. Part Specification

The functional requirements are detailed below:

- 2.1 The RF/MW signal analyser (hereafter referred to as the "Spectrum & Phase Noise Analyser") must be capable of serving as a spectrum analyser, phase noise analyser, noise figure meter, and absolute power level meter.
- 2.2 The Spectrum & Phase Noise Analyser must operate over a frequency range of  $\leq 5$  MHz up to  $\geq 26$  GHz.
- 2.3 The Spectrum & Phase Noise Analyser must provide the following measurement results to the user -
  - (i) Single Sideband Phase Noise
  - (ii) Spurious Noise
  - (iii) RMS Phase Deviation
  - (iv) Residual FM
  - (v) Time Jitter
  - (vi) Frequency Spectrum
  - (vii) Noise Figure
  - (viii) RF Power Level
- 2.4 The Spectrum & Phase Noise Analyser must be supplied as a standalone unit which includes all user interfaces required to perform measurements as specified in this document. (As an example, if the unit proposed has no screen, this must be supplied as part of the unit).
- 2.5 The main RF measurement input port connector must be an APC-3.5 female.
- 2.6 The nominal input impedance of the measurement input port must be 50  $\Omega$ .
- 2.7 The minimum acceptable RF input power levels must be  $\leq -30$ dBm and the maximum acceptable RF input power (damage input power level) must be  $\geq +15$ dBm.



- 2.8 The external reference input connector must be BNC and must accept reference signals with power levels  $\geq 0$  dBm and  $\leq 10$ dBm.
- 2.9 The Spectrum and Phase Noise Analyser must measure the phase noise at frequency offsets from the carrier extending from 1Hz to 100 MHz.
- 2.10 The Spectrum and Phase Noise Analyser must accept an external frequency reference of 10MHz or 100 MHz.
- 2.11 The Spectrum and Phase Noise Analyser must have the capability to enhance its phase noise sensitivity via repeated cross correlations. The maximum number of cross correlations must be  $\geq 10000$ .
- 2.12 The phase noise sensitivity at 1x correlation at 7 GHz must be better than -
- (i) 1Hz: -57 dBc/Hz
  - (ii) 10Hz: -79 dBc/Hz
  - (iii) 100Hz: -102 dBc/Hz
  - (iv) 1kHz: -132 dBc/Hz
  - (v) 10kHz: -151 dBc/Hz
  - (vi) 100kHz: -152 dBc/Hz
  - (vii) 1MHz: -156 dBc/Hz
  - (viii) 10MHz: -165 dBc/Hz
  - (ix) 100MHz: -165 dBc/Hz
- 2.13 The phase noise sensitivity at 1x correlation at 26 GHz must be better than -
- (i) 1Hz: -46 dBc/Hz
  - (ii) 10Hz: -68 dBc/Hz
  - (iii) 100Hz: -91 dBc/Hz
  - (iv) 1kHz: -123 dBc/Hz
  - (v) 10kHz: -142 dBc/Hz
  - (vi) 100kHz: -143 dBc/Hz
  - (vii) 1MHz: -147dBc/Hz
  - (viii) 10MHz: -163 dBc/Hz
  - (ix) 100MHz: -164 dBc/Hz
- 2.14 The phase noise level measurement uncertainty must be <3dB.
- 2.15 The amplitude level uncertainty must be less than < 3 dB.
- 2.16 Internally generated spurs must be  $\leq -62$ dBc.
- 2.17 The frequency drift of the internal reference frequency must be less than  $\pm 1 \times 10^{-9}$  over a temperature range of 0 to 50 °C.
- 2.18 The frequency aging rate of the internal frequency reference must be better than  $\pm 1 \times 10^{-7}$  per year.

- 2.19 The Spectrum and Phase Noise Analyser minimum frequency resolution must be  $\leq 0.01\text{Hz}$ .
- 2.20 The Spectrum and Phase Noise Analyser maximum number of points must be  $\geq 10001$ .
- 2.21 The Spectrum and Phase Noise Analyser resolution and video bandwidth range must be settable to between 1 Hz and 10 MHz.
- 2.22 The Spectrum and Phase Noise Analyser must be able to display up to 8 GHz of frequency span.
- 2.23 The Spectrum and Phase Noise Analyser noise figure function must be able to measure noise figure up to 26 GHz.
- 2.24 The appointed supplier must provide a suitable noise source. The noise source equivalent noise resistance (ENR) must be between 13dB and 17 dB with an uncertainty of  $< 0.5\text{ dB}$ . VSWR of  $< 1.35:1$ .
- 2.25 The noise source must have an APC-3.5 male connector.
- 2.26 A dedicated protective enclosure must be provided with the noise source for protection and storage after use.
- 2.27 The Spectrum and Phase Noise Analyser power meter function must measure RF power from 1 MHz to 26 GHz using a dedicated power sensor.
- 2.28 The Spectrum and Phase Noise Analyser power meter function must measure RF Power between -20 dBm and 26 dBm.
- 2.29 The power meter must have an APC-3.5 male connector.
- 2.30 A dedicated protective enclosure must be provided with the power meter for protection and storage after use.
- 2.31 The Spectrum and Phase Noise Analyser must be compatible with South African 230V alternating current (AC) power with a frequency of 50 Hz.
- 2.32 The Spectrum and Phase Noise Analyser network interface must be RJ-45 10/100 Base-T Ethernet or 10/100/1000 Base-T compliant.
- 2.33 It must be possible to control the Spectrum and Phase Noise Analyser using SCPI type commands.
- 2.34 User manuals, software and power cords for the Spectrum and Phase Noise Analyser must be included.
- 2.35 Certificates of calibration for accuracy of the phase noise spectrum showing traceability to primary standards must be provided for the Spectrum and Phase Noise Analyser.

- 2.36 The Spectrum and Phase Noise Analyser must be supplied in a rugged, foam-lined hard carry case that can be used for safe transportation.
- 2.37 The bidder must provide a 3 year warranty.
- 2.38 The bid must include 2 (two) calibrations to cover the warranty period of the Spectrum and Phase Noise Analyser.

## **PACKAGING**

It must be packaged and delivered in the original OEM packaging which provides protection against electrostatic discharge and transportation.

Rugged, foam lined enclosures must also be provided for the 1) Spectrum and Phase Noise Analyser, 2) the noise source and 3) the power meter.

## **WARRANTY**

The appointed supplier must provide a 3-year warranty for the Spectrum and Phase Noise Analyser. We envisage this as being split in a 1 year warranty included with the standard unit and a 2 year warranty extension costed separately in the quotation. The warranty will start from the date of acceptance of delivery by SARAO.

## **DOCUMENTATION**

The item must be delivered with a certificate of compliance to its datasheets, to guarantee that the supplied item conforms to and will meet the performance as specified in the data sheets.

## **LEAD TIME AND DELIVERY**

Estimated lead time should be within 6 months of order placement or earlier. Bidders to confirm the lead time. Delivery must be to SARAO Offices at Liesbeek House, River Park, Gloucester Road, Mowbray, Cape Town within office hours, 8.00am – 16.00pm. Payment will be made upon delivery and acceptance of the instrument.

The National Research Foundation compiles separate Special Conditions of Contract (SCC) relevant to this bid where applicable supplementing the General Conditions of Contract. Where there is conflict, the provisions of the Special Conditions of Contract shall prevail.

<b>GCC 1</b>	<b>Definitions – The following terms shall be interpreted as indicated:</b>

1.7	“Day” means calendar day.
1.8	“Delivery” means delivery in compliance of the conditions of the contract or order.
1.9	“Delivery ex stock” means immediate delivery directly from stock actually on hand.
1.10	“Delivery into consignees store or to his site” means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained.
1.11	“Dumping” occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the RSA.

Disclosure made to any such employed person is in confidence and shall extend only as far as may be necessary for purposes of such performance.
