- (b) receive or have received any direct or indirect subsidy from any of them;
- (c) have the same legal representative for purposes of this Bid;
- (d) have a relationship with each other, directly or through common third parties, that puts them in a position to have access to information about or influence on the Bid of another Bidder, or influence the decisions of the Purchaser regarding this bidding process;
- (e) a Bidder participates in more than one bid in this bidding process. Participation by a Bidder in more than one Bid will result in the disqualification of all Bids in which it is involved. However, this does not limit the inclusion of the same subcontractor, not otherwise participating as a Bidder, in more than one bid; or
- (f) a Bidder or any of its affiliates participated as a consultant in the preparation of the design or technical specifications of the goods and services that are the subject of the bid.

4.4 A Bidder that is under a declaration of ineligibility by the GoN/DP in accordance with ITB 3.4, at the date of the deadline for bid submission or thereafter, shall be disqualified.

4.5 A GoN-owned enterprise may also participate in the bid if it is legally and financially autonomous, it operates under commercial law, and it is not dependent agency of the Purchaser.

4.6 Bidders shall provide such evidence of their continued eligibility satisfactory to the Purchaser, as the Purchaser shall reasonably request.

4.7 Firms shall be excluded in any of the cases, if

- (a) by an act of compliance with a decision of the United Nations Security Council taken under Chapter VII of the Charter of the United Nations prohibits any import of goods or Contracting of works or services from that country or any payments to persons or entities in that country.
- (b) DP Funded: as a matter of law or official regulation, GoN prohibits commercial relations with that country, provided that the DP is satisfied that such exclusion does not preclude effective competition for the supply of goods or related services required;

Technical Specification

A. GENERAL TECHNICAL SPECIFICATIONS FOR ALL DRUGS

1. Product and Package Specifications

- 1) The required packing standards and labeling must meet the latest requirements of the World Health Organization (WHO) good manufacturing practices (GMP) standards in all respects. (These standards are contained in “Good Practices in the Manufacture and Quality Control of Drugs.”)
- 2) Product specifications indicate dosage form (e.g., tablet, capsules, dry syrup, liquid, ointment, injectable, emulsion, suspension, etc.) and the drug content (exact number of mg or international units [IU] or % v/v, w/w or v/w acceptable range). The Goods should conform to standards specified in the compendia recognized by DDA/GON Nepal.
- 3) The Goods to be supplied shall be registered with the relevant authority in the (DDA/N) through either a valid marketing license if the product is manufactured in Nepal (Schedule 4B) or a valid import license and Product Sale license (Schedule 7 and 4E) issued by DDA/N in case the product is manufactured in foreign country.
- 4) Not only the pharmaceutical item, but also the packaging and labeling components (e.g., bottles, closures, and labeling) should also meet specifications suitable for distribution, storage, and use in a climate similar to that prevailing in Nepal. All packaging must be sealed and tamper-proof.
- 5) All labeling and packaging inserts shall be in English if not otherwise stated.
- 6) Goods requiring refrigeration or freezing or those that should not fall below a certain minimum temperature for stability must specifically indicate storage requirements on labels and containers and be shipped in special containers to ensure stability in transit from point of shipment to port of entry.
- 7) The successful Supplier shall, on demand, must provide a translated version in the English language of the information for the goods to be supplied



2. Labeling Instructions

The label of the primary container for each pharmaceutical and vaccine products shall meet the WHO GMP standard and include:

- The international nonproprietary name (INN) or generic name prominently displayed above the brand name
- dosage form, e.g., tablet, ampoule, syrup, etc.;
- the active ingredient “per unit, dose, tablet or capsule, etc.”;
- the applicable pharmacopoeial standard;
- content per pack;
- instructions for use;
- special storage requirements;
- batch number;
- date of manufacture and date of expiry (in clear language, not code);
- name and address of manufacture;
- any additional cautionary statement.

3. Case Identification

3.1 All cases should prominently indicate the following:

- the generic name of the product;
- the dosage form (tablet, ampoule, syrup);
- date of manufacture and expiry (in clear language not code);
- batch number
- quantity per case
- special instructions for storage
- name and address of manufacture;
- any additional cautionary statements.

3.2 No case should contain pharmaceutical products from more than one batch.

4. Unique Identifiers

- “केटाकेटीले नभेट्ने गरि राख्ने ” meaning “keep out of reach of children”
- Under no circumstances shall the Retail Price of Drugs be indicated on any part of the container of the Drugs.



5. Standards of Quality Control for Supply

- The successful Supplier if requested will be required to furnish to the Purchaser:
 - For each item a WHO certificate of quality control test results concerning quantitative assay, chemical analysis, sterility, pyrogen content uniformity, microbial limit, and other tests, as applicable to the Goods being supplied and the manufacturer's certificate of analysis, assay methodology of any or all tests if requested.
- The remaining shelf life at the time of delivery should be not less than 3/4th of the remaining shelf life of the product.
