<b>Description</b> Invitation to Bid for Provision of Free Internet Access in Public Spaces  1. The Department of Information and Communications Technology Region V, through the Automatic Appropriations - Free Public Internet Access 2025 Fund intends to apply the sum of Twenty One Million Pesos Only (Php 21,000,000.00) for Lot 1 of Provision of Free Internet Access in Public Spaces being the Approved Budget for the Contract (ABC) to payments under the contract for Provision of Free Internet Access in Public Spaces (RE-BID). Bids received in excess of the ABC for each lot shall be automatically rejected for bid opening.  2. The Department of Information and Communications Technology Region V now invites bids for Provision of Free Internet Access in Public Spaces. Delivery of the Goods is required within twenty (20) days upon receipt upon receipt of Notice to Proceed (NTP) or before February 28, 2026. Bidders should have completed, at least five (5) years from the date of submission and receipt of bids, contracts similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.  3. Bidding will be conducted through competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the IRR of RA No. 12009.  Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.  4. Interested Bidders may obtain further information from DICT Region V and inspect the Bidding Documents at the address given below from Mondays to Fridays 8:00 AM - 5:00 PM.  5. A complete set of Bidding Documents may be acquired by interested Bidders on December 29, 2025 from the address given below upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Twenty Five Thousand (Php25,000.00) Pesos only.  It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.  6. The Department of Information and Communications Technology Region V will hold a Pre-Bid Conference on January 6, 2026 at from 1:00 PM at Digital Transformation Center DICT Regional Office V, 2nd Floor Post Telecom Building Lapu Lapu St., Legazpi City, Albay and/or through video conferencing via <a href="https://meet.google.com/qil-fzxe-avt">https://meet.google.com/qil-fzxe-avt</a> ,which shall be open to prospective Bidders.  7. Bids must be duly received by the Bids and Awards Committee (BAC) Secretariat through [(i) manual submission at the office address indicated below, on or before January 19, 2026 at 12:00 NN. Late bids shall not be accepted.  8. All Bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in ITB Clause 16.1.  9. Bid opening shall be on January 19, 2026 at 1:00 PM at the Digital Transformation Center DICT Regional Office V, 2nd Floor Post Telecom Building Lapu Lapu St., Legazpi City, Albay and/or via <a href="https://meet.google.com/gmq-iuex-sdx">https://meet.google.com/gmq-iuex-sdx</a> .Bids will be opened in the presence of the Bidders’ representatives who choose to attend the activity.  10.
